
# STATUTORY AND OTHER OFFICES REMUNERATION (PLUMBERS, GASFITTERS AND DRAINERS) AMENDMENT BILL, 1979

#### EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Plumbers, Gasfitters and Drainers Bill, 1979.

The object of this Bill is to include in the Schedule of Public Offices in the Statutory and Other Offices Remuneration Act, 1975, the office of Chairman of the Plumbers, Gasfitters and Drainers Board consequentially upon the enactment of the proposed Plumbers, Gasfitters and Drainers Act, 1979.

An Act to amend the Statutory and Other Offices Remuneration Act, 1975, consequentially upon the enactment of the Plumbers, Gasfitters and Drainers Act, 1979.

Statutory and Other Offices Remuneration (Plumbers, Gasfitters and Drainers) Amendment.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

- 5 1. This Act may be cited as the "Statutory and Other Offices Short title. Remuneration (Plumbers, Gasfitters and Drainers) Amendment Act, 1979".
  - **2.** (1) Except as provided by subsection (2), this Act shall Commence-commence on the date of assent to this Act.

An Act to amend the Statutory and Other Offices Remuneration Act, 1975, consequentially upon the enactment of the Plumbers, Gasfitters and Drainers Act, 1979. [Assented to, 9th May, 1979.]

Statutory and Other Offices Remuneration (Plumbers, Gasfitters and Drainers) Amendment.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title. 1. This Act may be cited as the "Statutory and Other Offices Remuneration (Plumbers, Gasfitters and Drainers) Amendment Act, 1979".

Commence 2. (1) Except as provided by subsection (2), this Act shall commence on the date of assent to this Act.

- (2) Section 3 shall commence on the day appointed and notified under section 2 (2) of the Plumbers, Gasfitters and Drainers Act, 1979.
- Amendment of Act No. 4, 1976. Sch. 2. The Statutory and Other Offices Remuneration Act, 1975, is amended by inserting at the end of Part 1 of Schedule 2 the words "Chairman of the Plumbers, Gasfitters and Drainers Board.".
