- (a) to amend the Strata Titles Act, 1973, consequentially upon amendments to be made by the proposed Auctioneers and Agents (Amendment) Act, 1980, requiring strata managing agents to be licensed under the Auctioneers and Agents Act, 1941, and requiring agency agreements to be in writing (Schedule 1 (1), (2), (4), (6), (7) and (8));
- (b) to make provision with respect to the handing over of certain records by strata managing agents on demand or on termination of appointment (Schedule 1 (3)); and
- (c) to require a strata managing agent to furnish, on demand, particulars of accounts or transactions to the body corporate for or on behalf of which he acts (Schedule 1 (5)—proposed section 79).
