

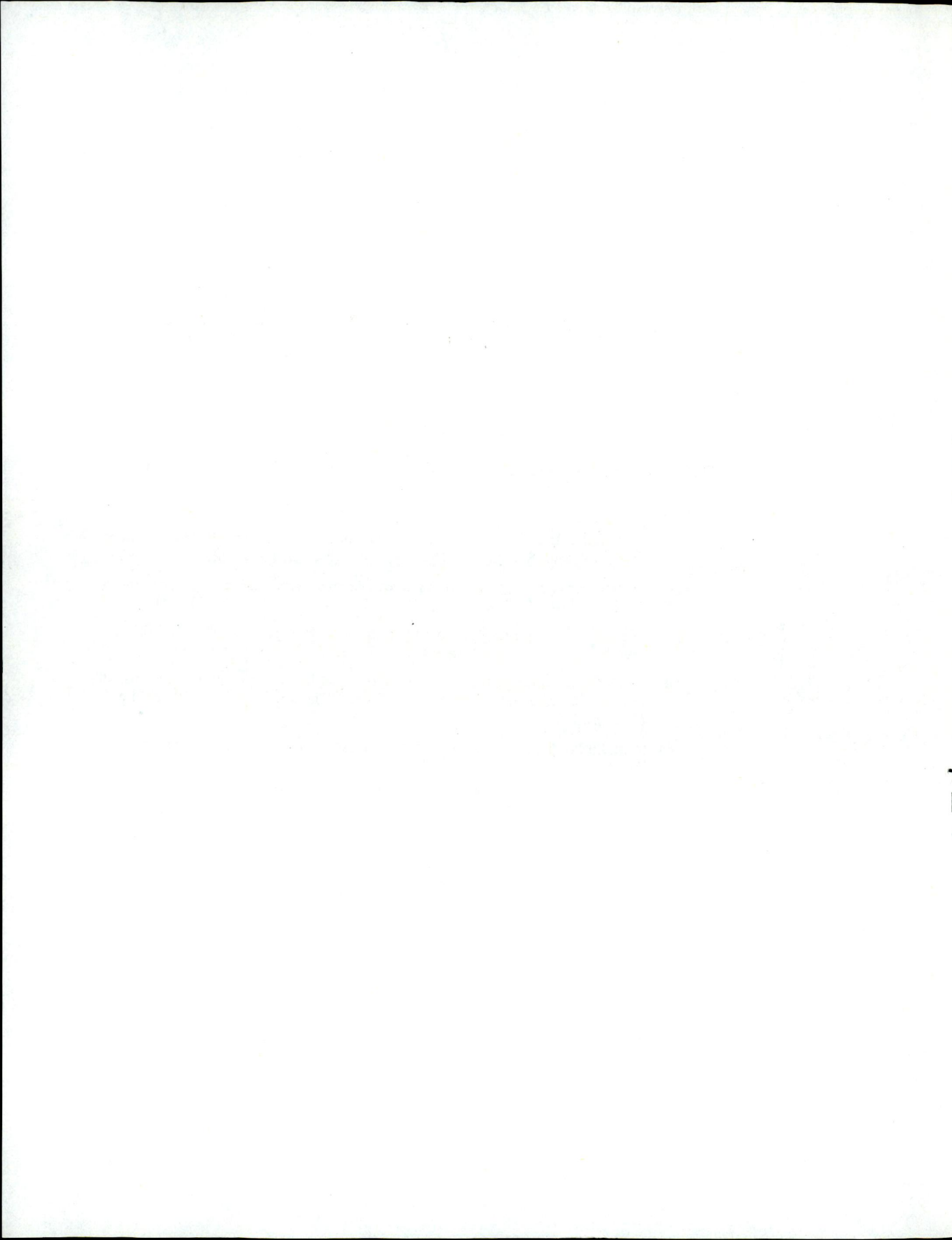
**THE GREAT SYNAGOGUE, SYDNEY (AMENDMENT)
BILL, 1979**

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to amend The Great Synagogue, Sydney, Act, 1931—

- (a) to increase the number of Vice-Presidents of the Board of Management of The Great Synagogue, Sydney, from 1 to 2 (Schedule 1 (1) (a));
 - (b) to increase the maximum number of life members who may be appointed to the Board of Management, from 2 to 4 (Schedule 1 (1) (d));
 - (c) to allow the appointment to the Board of Management of an additional member or 2 additional members (Schedule 1 (1) (e));
 - (d) to alter the procedures relating to the passing of special resolutions at meetings of the members of The Great Synagogue, Sydney (Schedule 1 (5)); and
 - (e) to make other provisions of a minor, consequential or ancillary nature.

A BILL FOR

An Act to amend The Great Synagogue, Sydney, Act, 1931, with respect to the constitution and certain meetings of the Board of Management of The Great Synagogue, Sydney.

The Great Synagogue, Sydney (Amendment).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

5 **1.** This Act may be cited as “The Great Synagogue, Sydney Short title.

An Act to amend The Great Synagogue, Sydney, Act, 1931, with respect to the constitution and certain meetings of the Board of Management of The Great Synagogue, Sydney. [Assented to, 14th December, 1979.]

The Great Synagogue, Sydney (Amendment).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

Short title. **1.** This Act may be cited as "The Great Synagogue, Sydney (Amendment) Act, 1979".

Commence- **2.** (1) Except as provided in subsection (2), this Act shall
ment. commence on the date of assent to this Act.

(2) Section 3 and Schedule 1 shall commence on such day as may be appointed by the Governor in respect thereof and as may be notified by proclamation published in the Gazette.

Omit "Vice-President or Treasurer" where firstly occurring, insert instead "a Vice-President or the Treasurer".
