**EXPLANATORY NOTE**

This Bill is cognate with the Totalizator (Off-course Betting) Amendment Bill, 1981.

The object of this Bill is to amend the Totalizator Act, 1916, to permit the Minister to authorise payments out of the Racecourse Development Fund to the Greyhound Racing Control Board and the Trotting Authority of New South Wales to meet expenses of a capital nature.

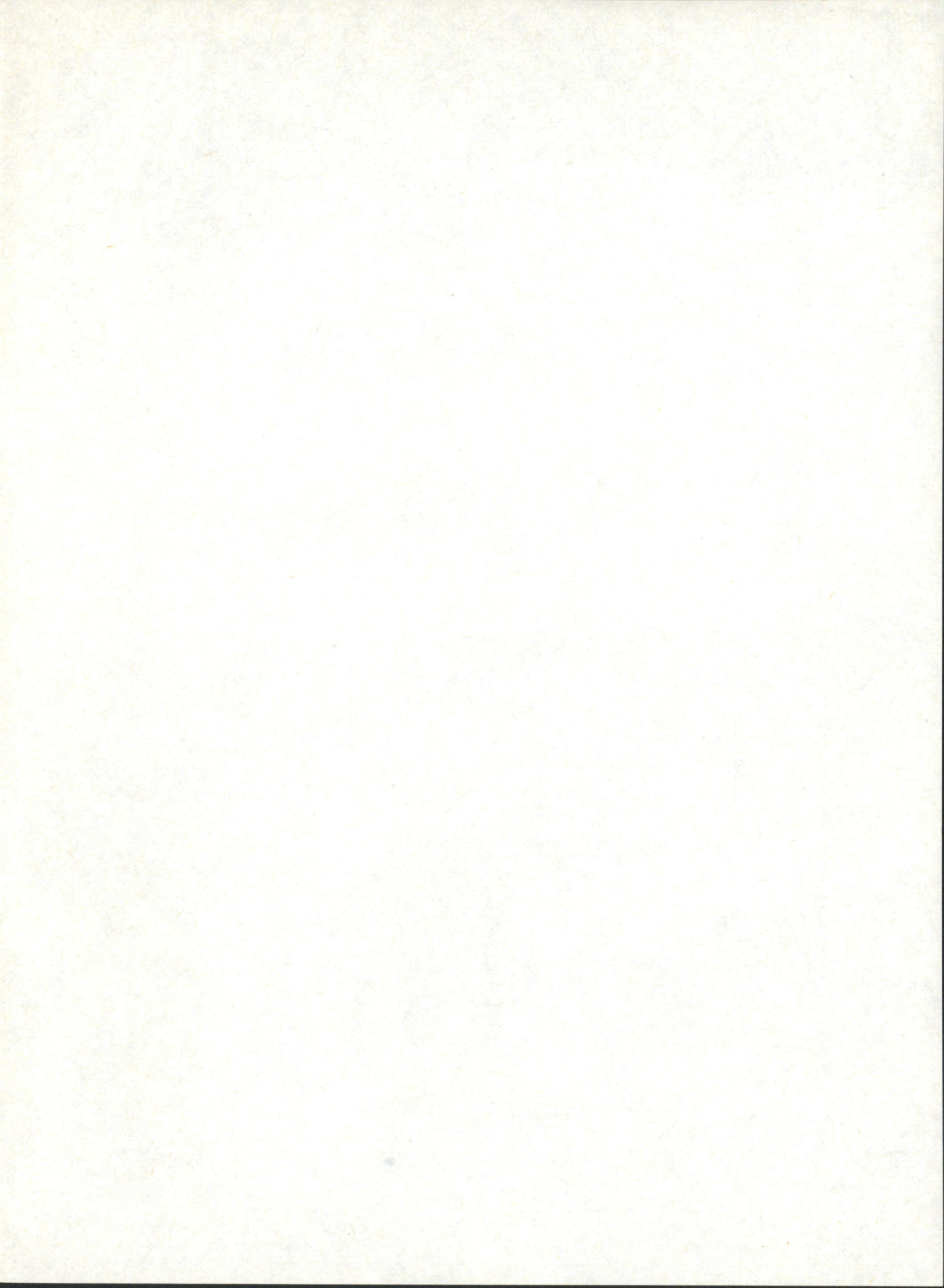

(c) In the case of a taxpayer who is a resident of this state for purposes of the Taxation Act, the amount of the taxpayer's liability for tax shall be determined by the amount of the taxpayer's net income as determined under the provisions of this section, and the amount of the taxpayer's net income shall be determined in the same manner as the amount of the taxpayer's net income is determined under the provisions of this section.
