An Act to amend the Transport Authorities Act, 1980, to increase the penalty for a contravention of a regulation made under that Act and by way of statute law revision.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—





An Act to amend the Transport Authorities Act, 1980, to increase the penalty for a contravention of a regulation made under that Act and by way of statute law revision. [Assented to, 9th December, 1980.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Transport Authorities (Amendment) Act, 1980".

Commencement.
