

**UNIVERSITY OF NEW ENGLAND (AMENDMENT)
BILL, 1980**

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the University of Newcastle (Amendment) Bill, 1980.

The objects of this Bill are—

- (a) to amend section 10 of the University of New England Act, 1953 (“the Principal Act”), to provide that any person (not being a member of the Council of the University of New England (“the University”)) acting in the place of the Chairman of the Academic Board of the University or in place of the Principal of the Armidale College of Advanced Education shall, while he is so acting, be deemed to be an official member of the Council of the University (Schedule 1); and
 - (b) to amend the Principal Act by way of statute law revision (Schedule 2).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

Short title. 1. This Act may be cited as the "University of New England (Amendment) Act, 1980".

Commence-ment. 2. (1) Except as provided in subsection (2), this Act shall commence on the date of assent to this Act.
