



Act No. 181, 1980.

An Act to amend the Wheat Marketing Act, 1979, as a consequence of the enactment of the Grain Handling (Amendment) Act, 1980. [Assented to, 17th December, 1980.]

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Wheat Marketing (Grain Handling) Amendment Act, 1980".

Commencement.

- 2. (1) This section and section 1 shall commence on the date of assent to this Act.
- (2) Except as provided in subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Grain Handling (Amendment) Act, 1980.

Amendment of Act No. 202, 1979.

3. The Wheat Marketing Act, 1979, is amended—

Sec. 5. (Interpretation.)

(a) by omitting from section 5 (1) the definition of "Grain Elevators Board" and by inserting instead the following definition:—

"Grain Handling Authority" means the Grain Handling Authority of New South Wales constituted under the Grain Handling Act, 1954;

Secs. 7, 8 and 27. (b) by omitting from sections 7 (3), 8 and 27 (1) the words "Grain Elevators Board" wherever occurring and by inserting instead the words "Grain Handling Authority";

(c) by omitting from section 11 (4) the words "Grain Sec. 11.

Elevators Act, 1954" and by inserting instead the words (Delivery to authorised receiver.)
