## **BROKEN HILL WATER AND SEWERAGE (RATES) AMENDMENT BILL, 1983**

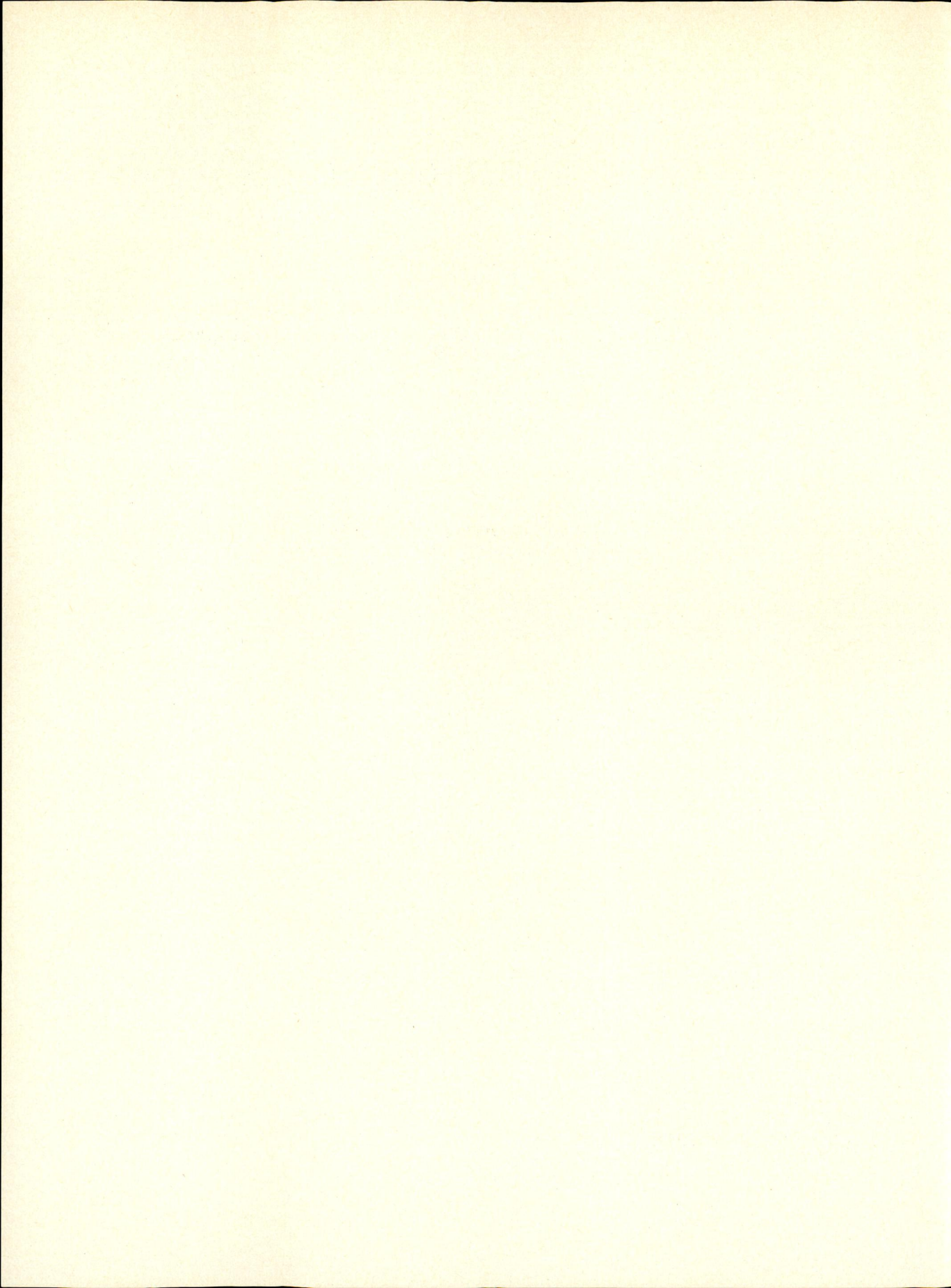

### **EXPLANATORY NOTE**

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

The object of this Bill is to amend the Broken Hill Water and Sewerage Act, 1938, so as to reduce by half the amount reimbursed to the Broken Hill Water Board for rates written off by that Board as reductions to pensioners.

*Broken Hill Water and Sewerage (Rates) Amendment.*

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**5 Short title.**

**1.** This Act may be cited as the "Broken Hill Water and Sewerage (Rates) Amendment Act, 1983".

**Commencement.**

**2.** This Act shall be deemed to have commenced on 1st January, 1983.

**10 Principal Act.**

**3.** The Broken Hill Water and Sewerage Act, 1938, is referred to in this Act as the Principal Act.

**Amendment of Act No. 20, 1938.**

**4.** The Principal Act is amended by inserting in section 87A (13) after 15 the words "equal to" the word "half".

**Savings.**

**5.** Nothing in the Principal Act, as amended by this Act, affects the liability of the Minister to pay an amount equal to that written off pursuant to section 87A of the Principal Act, as in force immediately before 1st January, 20 1983, in respect of a rate made and levied for the year commencing on 1st January, 1982, or any preceding year.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**Short title.**

1. This Act may be cited as the "Broken Hill Water and Sewerage (Rates) Amendment Act, 1983".

**Commencement.**

2. This Act shall be deemed to have commenced on 1st January, 1983.
