## **CORONERS (COMMUNITY WELFARE) AMENDMENT BILL, 1982**

### **EXPLANATORY NOTE**

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

This Bill is cognate with the Community Welfare Bill, 1982.

**The object of this Bill is to provide that deaths or suspected deaths occurring in facilities established by the Minister under the Community Welfare Act, 1982, or licensed residential child care centres, intellectually handicapped persons centres or residential centres for handicapped persons under that Act are examinable by a coroner.**

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**5 Short title.**

**1.** This Act may be cited as the "Coroners (Community Welfare) Amendment Act, 1982".

**Commencement.**

**2. (1)** This section and section 1 shall commence on the date of assent to  
10 this Act.

**(2)** Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the **Community Welfare Act, 1982.**
