### **CRIMES (ROAD SAFETY) AMENDMENT BILL, 1982**

### EXPLANATORY NOTE

#### (This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Motor Traffic (Road Safety) Amendment Bill, 1982.

The object of this Bill is to amend the Crimes Act, 1900, to enable a certificate given under section 4G of the Motor Traffic Act, 1909 (as proposed to be amended by the Motor Traffic (Road Safety) Amendment Bill, 1982), for the purpose of proceedings for offences relating to prescribed concentrations of alchohol, to be admissible, as prima facie evidence, at an inquest or in proceedings for an indictable offence. A similar provision exists in the Crimes Act, 1900, with respect to certificates relating to breath analyses.

### 5 Short title.

1. This Act may be cited as the "Crimes (Road Safety) Amendment Act, 1982".

### Commencement.

2. (1) Sections 1 and 2 shall commence on the date of assent to this 10 Act.

(2) Except as provided by subsection (1), this Act shall commence on 17th December, 1982.




