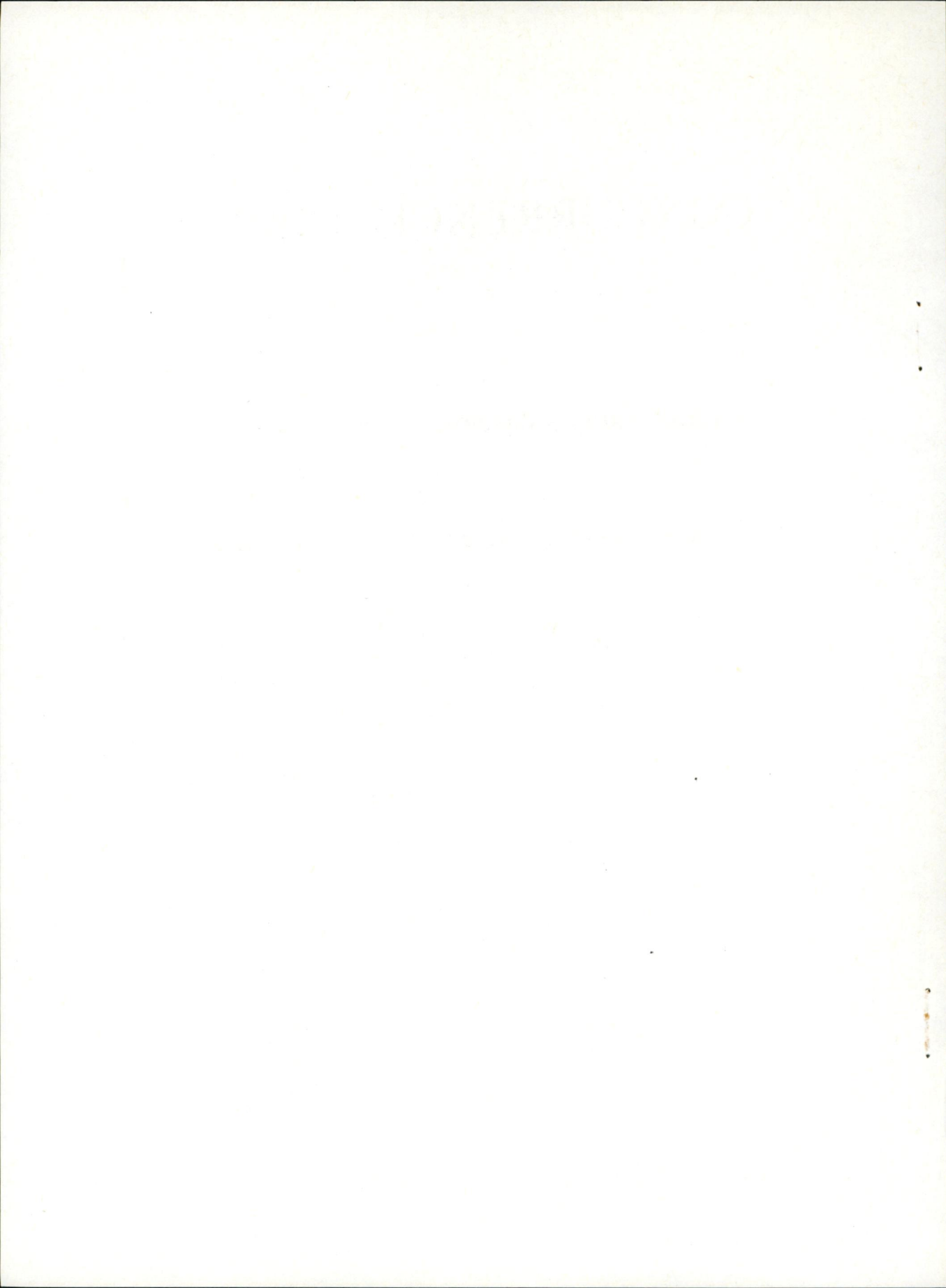
DRIED FRUITS (AMENDMENT) BILL, 1982

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to amend the Dried Fruits Act, 1939—

- (a) to increase the maximum amount of the contributions payable by packers of dried fruits to meet the expenditure of the New South Wales Dried Fruits Board (Schedule 1); and
 - (b) to increase the penalties for offences under that Act (Schedule 2).

An Act to amend the Dried Fruits Act, 1939, to increase the maximum amount of the contributions payable under that Act and to increase the penalties for offences under that Act.

Dried Fruits (Amendment).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—
