### FISH RIVER WATER SUPPLY ADMINISTRATION (AMENDMENT) BILL, 1982

### **EXPLANATORY NOTE**

#### (This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Junee Water Supply Administration (Repeal) Bill, 1982.

The object of this Bill is to amend the Fish River Water Supply Administration Act, 1945 ("the Act"), so as—

- (a) to remove the limit of 4 per cent on the rate of interest that the Treasurer may approve in relation to—
  - (i) expenditure from the Fish River Water Supply Renewal Reserve Account kept under the Act (Schedule 1 (1) (b)); and
  - (ii) borrowings under section 14 of the Act (Schedule 1 (2));
- (b) to provide for the payment of interest, at such rate as the Treasurer may approve, in relation to contributions to the Fish River Water Supply Renewal Reserve Account that have been deferred pursuant to section 13 (6) of the Act (Schedule 1 (1) (d)—proposed section 13 (7));

(c) to make amendments by way of statute law revision (Schedule 2); and

(d) to make other provisions of a minor, consequential or ancillary nature.

### 5 Short title.
