## GAS AND ELECTRICITY (AMENDMENT) BILL, 1981

---

### EXPLANATORY NOTE

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

This Bill is cognate with the Local Government (City of Sydney Boundaries) Bill, 1981.

The objects of this Bill are—

- (a) to omit references to the Municipality of South Sydney from Schedules 3 and 6 to the Gas and Electricity Act, 1935, as a consequence of the uniting of that area with the City of Sydney by the proposed Local Government (City of Sydney Boundaries) Act, 1981 (Schedule 1); and
  - (b) to provide that references in those Schedules to the City of Sydney shall be considered to be references to the local government area to be constituted by the uniting of the present City of Sydney and Municipality of South Sydney pursuant to that proposed Act (clause 5).

**GAS AND ELECTRICITY (AMENDMENT) BILL, 1981**

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

2 Short title.

1. This Act may be cited as the "Gas and Electricity (Amendment) Act, 1981."

Commencement.

2. (1) This section and section 1 shall commence on the date of assent to this Act.

(2) Except as provided by subsection (1), this Act shall commence on 1st January, 1982.

Principal Act.

3. The Gas and Electricity Act, 1935, is referred to in this Act as the Principal Act.

**5 Short title.**

1. This Act may be cited as the "Gas and Electricity (Amendment) Act, 1981".

**Commencement.**

2. (1) This section and section 1 shall commence on the date of assent 10 to this Act.

(2) Except as provided by subsection (1), this Act shall commence on 1st January, 1982.

**Principal Act.**

3. The Gas and Electricity Act, 1935, is referred to in this Act as the 15 Principal Act.

**Amendment of Act No. 42, 1935.**

4. The Principal Act is amended in the manner set forth in Schedule 1.

**Saving.**

5. The references, in Schedules 3 and 6 to the Principal Act, to the 20 City of Sydney shall be read and construed as references to the united area, within the meaning of the Local Government (City of Sydney Boundaries) Act, 1981.
