### **EXPLANATORY NOTE**

This Bill is cognate with the Metropolitan Water, Sewerage, and Drainage (Amendment) Bill, 1983.

The object of this Bill is to amend the Hunter District Water, Sewerage and Drainage Act, 1938, so as to reduce by half the amount reimbursed to The Hunter District Water Board for rates written off by that Board as reductions to pensioners.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**5 Short title.**

1. This Act may be cited as the "Hunter District Water, Sewerage and Drainage (Rates) Amendment Act, 1983".

**Commencement.**

2. This Act shall be deemed to have commenced on 1st July, 1983.

**10 Principal Act.**

3. The Hunter District Water, Sewerage and Drainage Act, 1938, is referred to in this Act as the Principal Act.

**Amendment of Act No. 11, 1938.**

4. The Principal Act is amended by inserting in section 104A (13) after 15 the words "equal to" the word "half".

**Savings.**

5. Nothing in the Principal Act, as amended by this Act, affects the liability of the Minister to pay an amount equal to that written off pursuant to section 104A of the Principal Act, as in force immediately before 1st July, 20 1983, in respect of a rate made and levied for the year commencing on 1st July, 1982, or any preceding year.
