EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Community Welfare Bill, 1982.

The objects of this Bill are to make provision giving effect to orders for the payment of weekly or other periodical sums made by a court of petty sessions in the **exercise** of the powers and authorities conferred on such a court by Part I of the Infants' Custody and Settlements Act, 1899 (the "Principal Act"), and to apply certain provisions of the proposed Community Welfare Act, 1982, relating to publicity of proceedings and publication of names of, or reports specifying, children involved in proceedings in courts of petty sessions under the Principal Act.

Infants' Custody and Settlements (Community Welfare) Amendment.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Infants' Custody and Settlements (Community Welfare) Amendment Act, 1982".

Commencement.

2. (1) This section and section 1 shall commence on the date of assent 10 to this Act.

(2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Community Welfare Act, 1982.
