### **EXPLANATORY NOTE**

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

This Bill is cognate with the Public Authorities Superannuation Board Bill, 1983.

The object of this Bill is to amend the Local Government and Other Authorities (Superannuation) Act, 1927, consequentially upon the proposed abolition of the Local Government Superannuation Board and the constitution of a Public Authorities Superannuation Board by providing for the new Board to take over the administration of the insurance scheme and funds established under that Act.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**5 Short title.**

**1.** This Act may be cited as the "Local Government and Other Authorities (Public Authorities Superannuation Board) Amendment Act, 1983".

**Commencement.**

**2. (1)** Sections 1 and 2 shall commence on the date of assent to this  
10 Act.

**(2)** Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Public Authorities Superannuation Board Act, 1983.

**Amendment of Act No. 35, 1927.**

**15 3.** The Local Government and Other Authorities (Superannuation) Act, 1927, is amended in the manner set forth in Schedule 1.

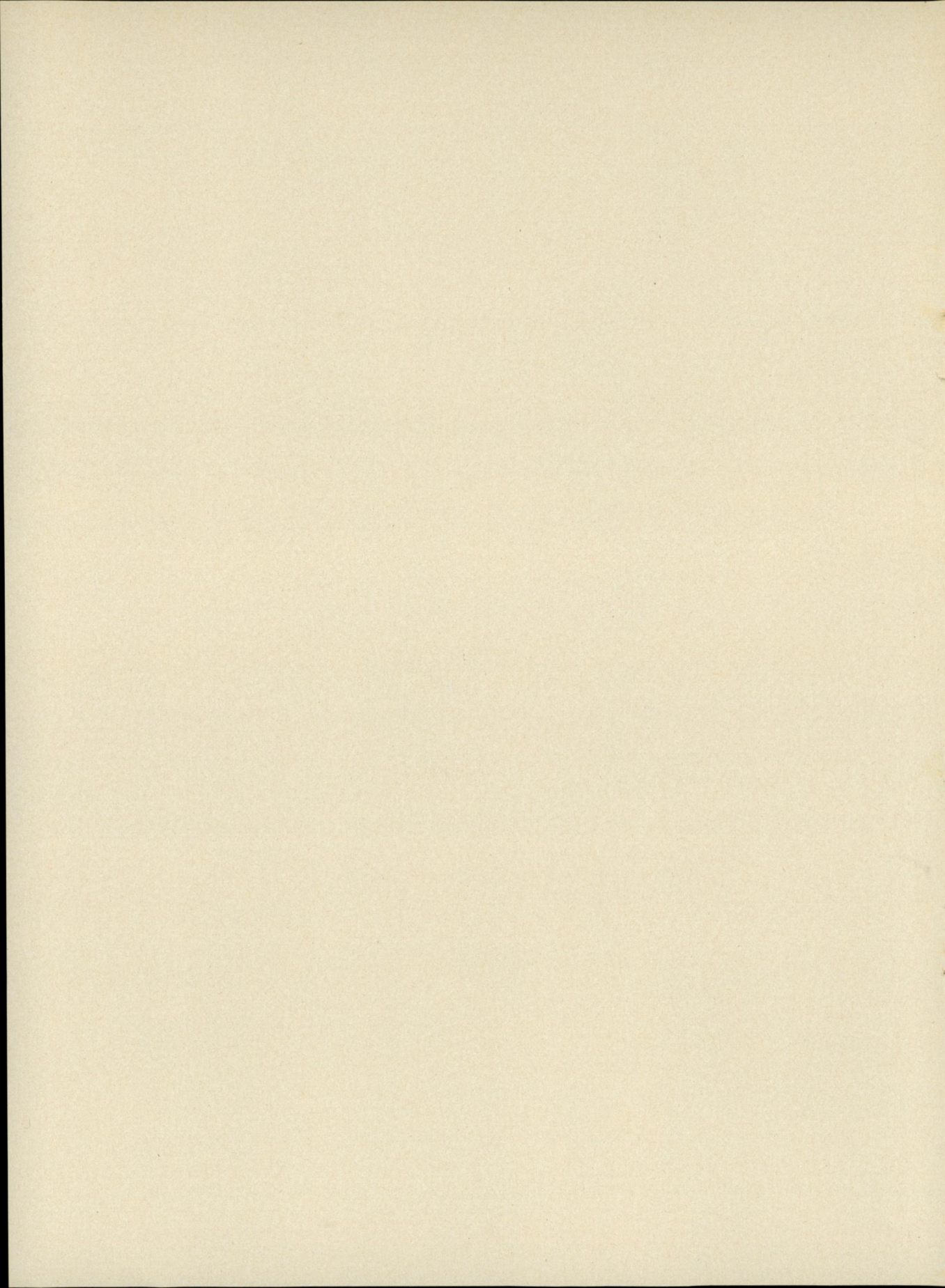

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**Short title.**

1. This Act may be cited as the "Local Government and Other Authorities (Public Authorities Superannuation Board) Amendment Act, 1983".

**Commencement.**

2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.

(2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Public Authorities Superannuation Board Act, 1983.

**Amendment of Act No. 35, 1927.**

3. The Local Government and Other Authorities (Superannuation) Act, 1927, is amended in the manner set forth in Schedule 1.
