LOTTO (AMENDMENT) BILL, 1982

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to amend section 15A of the Lotto Act, 1979, so as to enable the Minister to determine, from time to time, in respect of certain subscriptions to a game of lotto, being those subscriptions made within another State or Territory of the Commonwealth which has been declared to be a participating area under that Act, the proportion of the duty or additional duty that is to be paid to that State or Territory.

Lotto (Amendment)

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Lotto (Amendment) Act, 1982".
