## MISCELLANEOUS ACTS (ANTI-DISCRIMINATION) AMENDMENT BILL, 1982

### EXPLANATORY NOTE

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

This Bill is cognate with the Anti-Discrimination (Amendment) Bill, 1982.

The objects of this Bill are—

- (a) to amend the Defamation Act, 1974, in consequence of the enactment of the Anti-Discrimination (Amendment) Act, 1982 (Schedule 1); and
  - (b) to amend the Statutory and Other Offices Remuneration Act, 1975—
    - (i) to remove the reference, in Schedule 1 to that Act, to the office of Counsellor for Equal Opportunity, which office will be abolished by the enactment of the Anti-Discrimination (Amendment) Act, 1982 (Schedule 2 (1) (a)); and
    - (ii) to vary the provision made with respect to the remuneration of the Director of Equal Opportunity in Public Employment and the President of the Anti-Discrimination Board (Schedule 2 (1) (b) and (2)).

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**5 Short title.**

**1.** This Act may be cited as the "Miscellaneous Acts (Anti-Discrimination) Amendment Act, 1982".

**Commencement.**

**2. (1)** Sections 1 and 2 shall commence on the date of assent to this Act.

**10 (2)** Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Anti-Discrimination (Amendment) Act, 1982.

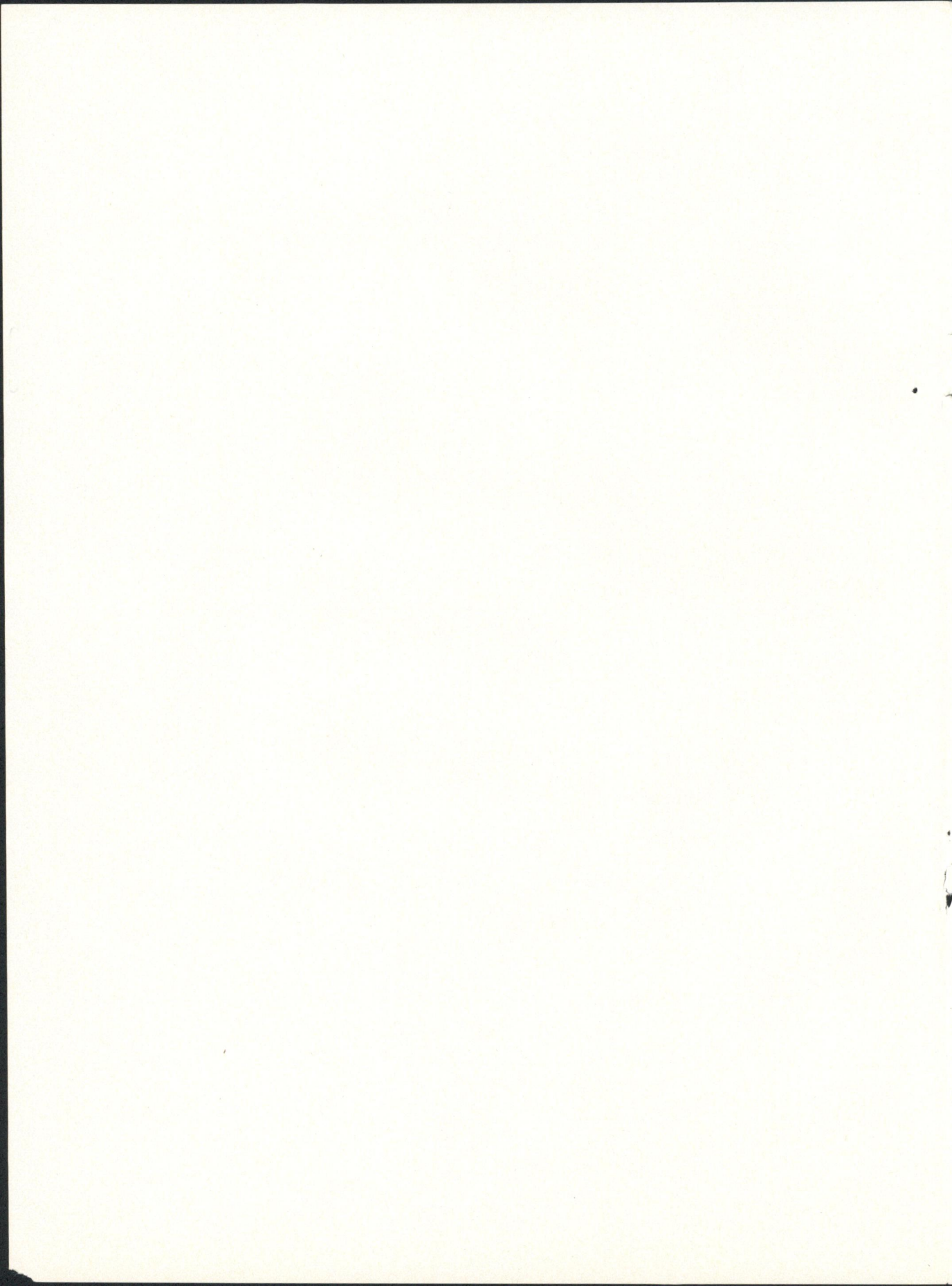
