EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Transport Authorities (Amendment) Bill, 1982.

The objects of this Bill are—

- (a) to amend Schedule 1 to the Miscellaneous Acts (Financial Accommodation) Amendment Act, 1981, so as to modify a reference to provisions of the Transport Authorities Act, 1980, repealed by the firstmentioned Act as a consequence of the enactment of the Public Authorities (Financial Accommodation) Act, 1981 (clause 3); and
 - (b) to make a saving provision and a validation provision with respect to that amendment (clauses 4 and 5).

- (b) to make a reference to provision and a validation provision with respect to the said Amendment Act 1981 (clause 3); and
- (c) to amend sub-section 1 to the Amendment Act (Financial Appropriation) Act 1981, so as to modify a reference to provision.

Miscellaneous Acts (Financial Accommodation) Amendment.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Miscellaneous Acts (Financial Accommodation) Amendment Act, 1982".

Commencement.

2. (1) Except as provided in subsection (2), this Act shall commence on
10 the date of assent to this Act.

(2) Sections 3 and 4 shall be deemed to have commenced on the date of assent to the Public Authorities (Financial Accommodation) Act, 1981.

Amendment of Act No. 83, 1981.

3. The Miscellaneous Acts (Financial Accommodation) Amendment
15 Act, 1981, is amended by omitting from item (3) of the matter relating to the Transport Authorities Act, 1980, appearing in Schedule 1 to the first-mentioned Act the matter "69-71" and by inserting instead the matter "69, 70".

Saving.

20 4. Section 6 of the Interpretation Act, 1897, does not apply to or in respect of the repeal effected by section 3.

Validation.

5. (1) In this section, "Authority" has the meaning ascribed thereto in section 4 (1) of the Transport Authorities Act, 1980.

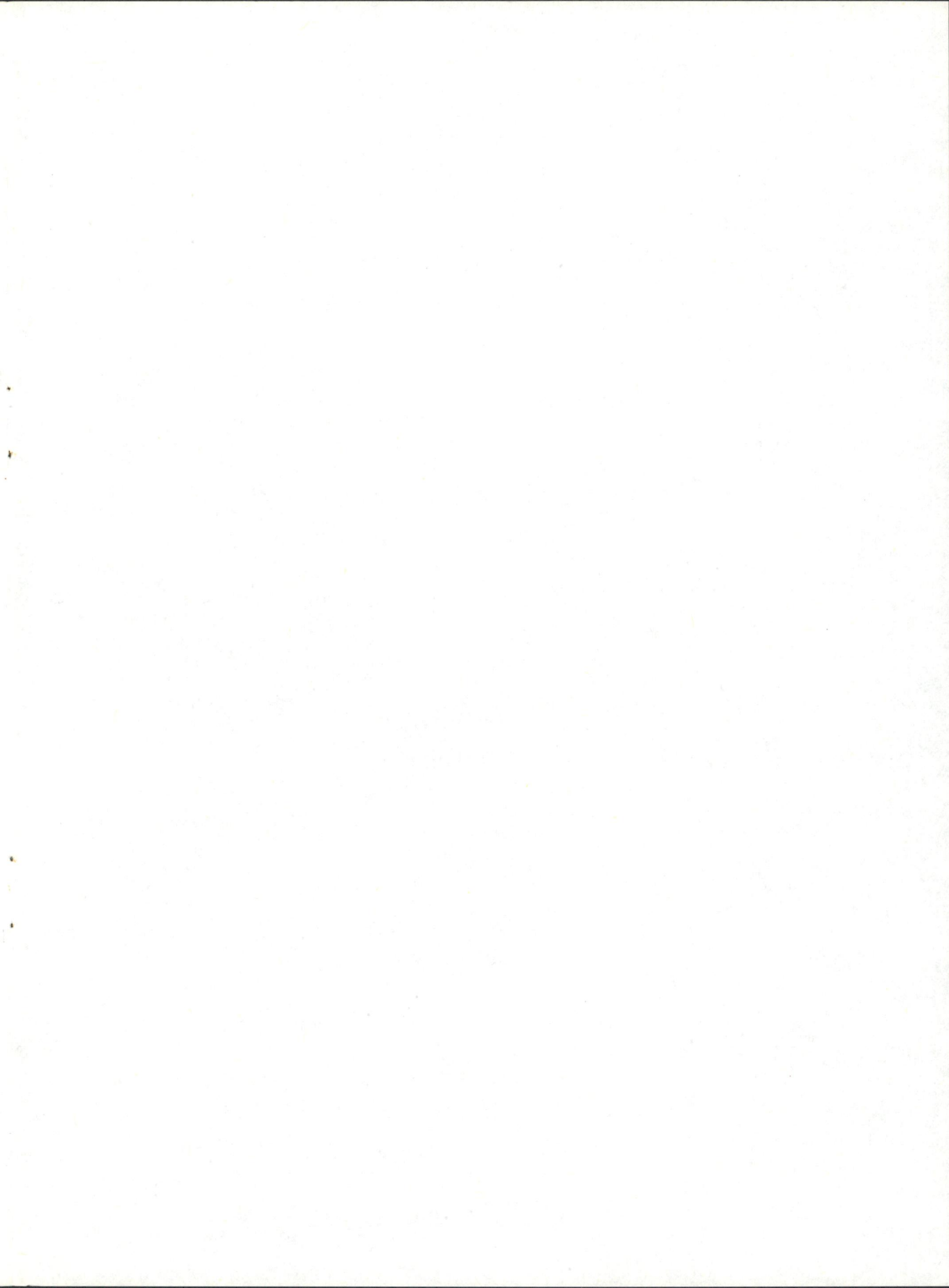

Miscellaneous Acts (Financial Accommodation) Amendment.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Miscellaneous Acts (Financial Accommodation) Amendment Act, 1982".

Commencement.

2. (1) Except as provided in subsection (2), this Act shall commence on the date of assent to this Act.

(2) Sections 3 and 4 shall be deemed to have commenced on the date of assent to the Public Authorities (Financial Accommodation) Act, 1981.
