
MISCELLANEOUS ACTS (NATIONAL PARKS AND WILDLIFE) AMENDMENT BILL, 1983

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the National Parks and Wildlife (Amendment) Bill, 1983.

The object of this Bill is to amend certain Acts in consequence of the enactment of the proposed National Parks and Wildlife (Amendment) Act, 1983.

A BILL FOR

An Act to amend certain Acts in consequence of the enactment of the National Parks and Wildlife (Amendment) Act, 1983.

[Mr Bedford—21 September, 1983.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Miscellaneous Acts (National Parks and Wildlife) Amendment Act, 1983".

Commencement.

- 2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.
- 10 (2) Except as provided by subsection (1), this Act shall commence or shall be deemed to have commenced, as the case may require, on the date of assent to the National Parks and Wildlife (Amendment) Act, 1983.

Amendments.

3. Each Act specified in Schedule 1 is amended in the manner set forth 15 in that Schedule.

Act No. 186, 1983.

An Act to amend certain Acts in consequence of the enactment of the National Parks and Wildlife (Amendment) Act, 1983. [Assented to, 31st December, 1983.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Miscellaneous Acts (National Parks and Wildlife) Amendment Act, 1983".

Commencement.

- 2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.
- (2) Except as provided by subsection (1), this Act shall commence or shall be deemed to have commenced, as the case may require, on the date of assent to the National Parks and Wildlife (Amendment) Act, 1983.
