
EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Recreation Vehicles Bill, 1983.

The object of this Bill is to amend the Motor Traffic Act, 1909, so as-

- (a) to prohibit a parent of a child (being a child who has not attained the age of 16 years and 9 months) from causing or permitting the child to drive a motor vehicle upon a public street; and
- (b) to enable penalty notices to be issued under section 18B of that Act in respect of certain offences under the proposed Recreation Vehicles Act, 1983.

A BILL FOR

An Act to amend the Motor Traffic Act, 1909, in relation to the driving of motor vehicles by children and in relation to the issue of penalty notices under section 18B of that Act in respect of certain offences under the Recreation Vehicles Act, 1983.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Motor Traffic (Recreation Vehicles) Amendment Act, 1983".

Commencement.

- 2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.
- 10 (2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Recreation Vehicles Act, 1983.






