NAVIGATION (COMMERCIAL VESSELS) AMENDMENT BILL, 1983

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Commercial Vessels (Amendment) Bill, 1983.

The objects of this Bill are—

- (a) to repeal provisions of the Navigation Act, 1901, relating to the number and qualifications of the crew of a vessel as a consequence of the proposed inclusion of those provisions in the Commercial Vessels Act, 1979 (Schedule 1 (1), (3), (5) and (6));
- (b) to make it clear that the jurisdiction of Courts of Marine Inquiry to suspend or cancel certificates of masters, mates or engineers extends to certificates of competency proposed to be issued under the Commercial Vessels Act, 1979 (Schedule 1 (2));
- (c) to enable the powers conferred on the Maritime Services Board of New South Wales ("the Board") to inspect vessels and documents, to require information to be given and to carry out investigations for the purposes of the Navigation Act, 1901, to be exercised for the purposes of the Commercial Vessels Act, 1979 (Schedule 1 (4)); and
- (d) to amend the Navigation Act, 1901, ("the Act") by way of statute law revision and in other minor, ancillary or consequential respects, and in particular—
 - (i) to alter references to the former Superintendent of the Department of Navigation to the Board (Schedule 2 (1) (a), (1) (b), (1) (d), (2) (d), (3), (4), (5), (6) (a), (8), (10), (11), (13), (14) (a), (14) (b), (16), (18), (20), (21), (23) (b), (23) (c), (24), (29), (33), (34), (39) and (47));
- (ii) to delete certain definitions that are no longer required (Schedule 2 (2) (a) and (c));
- (iii) to repeal certain obsolete provisions relating to the licensing and regulation of ballast and coal lighters and watermen (Schedule 2 (1) (f), (6) (b), (40) and (51));
 - (iv) to transfer the remaining provision in Part IV of the Act to a more appropriate place in the Act (Schedule 2 (1) (c), (17) and (31));

- (v) to alter references to British ships in provisions of the Act to ships generally in order that those provisions may continue to have operation as a consequence of ships being required to be registered as Australian ships instead of British ships by virtue of the Shipping Registration Act 1981 of the Commonwealth (Schedule 2 (9), (23) (a), (23) (d), (41) (a) and (43));
- (vi) to repeal provisions with respect to certain matters that are now dealt with in the Maritime Services Act, 1935 (Schedule 2 (1) (e), (7), (26), (37) and (42));
- (vii) to change references in the Act to the Treasurer consequent upon the transfer of the administration of the Act to the Minister for Ports (Schedule 2 (12), (15) and (19) (b));
- (viii) to delete references to police magistrates (Schedule 2 (18) (d) and (19) (a));
- (ix) to enable the regulations with respect to collisions at sea (which are at present contained in the Seventh Schedule to the Act and are amended from time to time by the Governor by proclamation) to be made and amended in the same way as other regulations under the Act (Schedule 2 (25), (28) and (49));
- (x) to provide that the regulations with respect to collisions at sea apply to inland navigable waters and to repeal provisions for the promulgation of separate regulations in respect of inland navigable waters (Schedule 2 (25) and (30));
- (xi) to provide that the owner or master of a vessel who contravenes, or causes to be contravened, the regulations relating to collisions at sea or in inland navigable waters may be found guilty of an offence without the necessity to establish (as at present) that the contravention was wilful (Schedule 2 (25) and (27));
- (xii) to delete obsolete regulations contained in the Act relating to the swinging of ships and the adjustment of compasses and to enable regulations on those matters to be made by the Governor (Schedule 2 (32) and (50));
- (xiii) to repeal certain Acts which conferred power on the Governor to make regulations under the Act relating to vehicular ferries and to make specific provision in the Act to confer that power on the Governor (Schedule 2 (35) and (46) and Schedule 3);
- (xiv) to repeal certain provisions relating to fairways of any port, being a matter that is now dealt with by the regulations relating to collisions at sea (Schedule 2 (36) and (38)); and

A BILL FOR

An Act to amend the Navigation Act, 1901, as a consequence of the enactment of the Commercial Vessels (Amendment) Act, 1983, for the purposes of statute law revision, and for other purposes.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Navigation (Commercial Vessels) Amendment Act, 1983".

Commencement.
