#### **EXPLANATORY NOTE**


## (This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Cinematograph Films (Suspension of Provisions) Bill, 1982.

The object of this Bill is to amend the New South Wales Film Corporation Act, 1977 ("the Act")—

- (a) to vary the maximum age at which a person may be appointed or re-appointed as the chief executive officer, or a director, of the New South Wales Film Corporation, or to a special office for the purposes of section 7 of the Act (Schedule 1 (1), (2) and (4)); and
- (b) to empower the Minister to appoint commissions of inquiry to inquire into any specified matters concerning any aspect of the film industry. (Schedule 1 (3)).

New South Wales Film Corporation (Amendment).

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

#### 5 Short title.

1. This Act may be cited as the "New South Wales Film Corporation (Amendment) Act, 1982".
