An Act to amend The City of Newcastle Gas and Coke Company's Incorporation Act 1866 to change the name of the body incorporated under that Act to the Hunter Valley Gas Company Limited and to make further provision with respect to the powers of that body.

Newcastle Gas Company Limited (Amendment).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Newcastle Gas Company Limited (Amendment) Act, 1982".

Commencement.

2. (1) This section, section 1 and Schedule 1 (2) shall commence on
10 the date of assent to this Act.

(2) Section 3, in its application to a provision of Schedule 1, shall commence on the day on which that provision commences.

(3) Except as provided in this section, this Act shall commence on
such day as may be appointed by the Governor in respect thereof and as
15 may be notified by proclamation published in the Gazette.
