#### EXPLANATORY NOTE


#### (This Explanatory Note relates to this Bill as introduced into Parliament)

The Inclosed Lands Protection (Amendment) Bill, 1983, is cognate with this Bill.

The object of this Bill is to amend section 5 of the Offences in Public Places Act, 1979, so as-

- (a) to make it an offence for a person to conduct himself or herself in, near or within view or hearing from a public place or school in such a manner as would be regarded by reasonable persons as being, in all the circumstances, offensive; and
- (b) to cast expressly on a person accused of such an offence the onus of establishing that the person had a reasonable excuse.

#### 5 Short title.


