#### EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Probation and Parole Bill, 1983.

The object of this Bill is to amend section 27 of the Periodic Detention of Prisoners Act, 1981, so that, where an order for periodic detention is cancelled under section 24 or 25 of that Act, the provisions of the proposed Probation and Parole Act, 1983, will apply to and in respect of the unexpired portion of the sentence to which the order applied, instead of the provisions of the Parole of Prisoners Act. 1966.

### Periodic Detention of Prisoners (Probation and Parole) Amendment.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

#### 5 Short title.

1. This Act may be cited as the "Periodic Detention of Prisoners (Probation and Parole) Amendment Act, 1983".

#### Commencement.

- 2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.
- 10 (2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified pursuant to section 2 (2) of the Probation and Parole Act, 1983.

### Amendment of Act No. 18, 1981.

3. The Periodic Detention of Prisoners Act, 1981, is amended by 15 omitting from section 27 (b) the words "Parole of Prisoners Act, 1966" and by inserting instead the words "Probation and Parole Act, 1983".
