
## PRISONERS (INTERSTATE TRANSFER) (PROBATION AND PAROLE) AMENDMENT BILL, 1983

#### EXPLANATORY NOTE

## (This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Probation and Parole Bill, 1983.

The object of this Bill is to amend section 26 of the Prisoners (Interstate Transfer) Act, 1982 ("the Act"), so as to provide that, where a prisoner is conveyed to a participating State, within the meaning of the Act, pursuant to an order of transfer made under the Act, the information required by that section to be sent to the participating State shall include details of any probation order made under the proposed Probation and Parole Act, 1983, with respect to the prisoner.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Prisoners (Interstate Transfer) (Probation and Parole) Amendment Act, 1983".

#### Commencement.

2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.

10 (2) Except as provided by subsection (1), this Act shall commence on—

(a) the day appointed and notified pursuant to section 2 (2) of the Probation and Parole Act, 1983; or

(b) the day on which section 26 of the Prisoners (Interstate Transfer) Act, 1982, commences,

whichever is the later day.

#### Amendment of Act No. 104, 1982.

3. The Prisoners (Interstate Transfer) Act, 1982, is amended by omitting from section 26 (1) (c) the words "grants of parole" and by inserting instead 20 the words "release on probation or parole".

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

#### Short title.

1. This Act may be cited as the "Prisoners (Interstate Transfer) (Probation and Parole) Amendment Act, 1983".

#### Commencement.

2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.

(2) Except as provided by subsection (1), this Act shall commence on—

- (a) the day appointed and notified pursuant to section 2 (2) of the Probation and Parole Act, 1983; or
- (b) the day on which section 26 of the Prisoners (Interstate Transfer) Act, 1982, commences,

whichever is the later day.

### Amendment of Act No. 104, 1982.

3. The Prisoners (Interstate Transfer) Act, 1982, is amended by omitting from section 26 (1) (c) the words "grants of parole" and by inserting instead the words "release on probation or parole".
