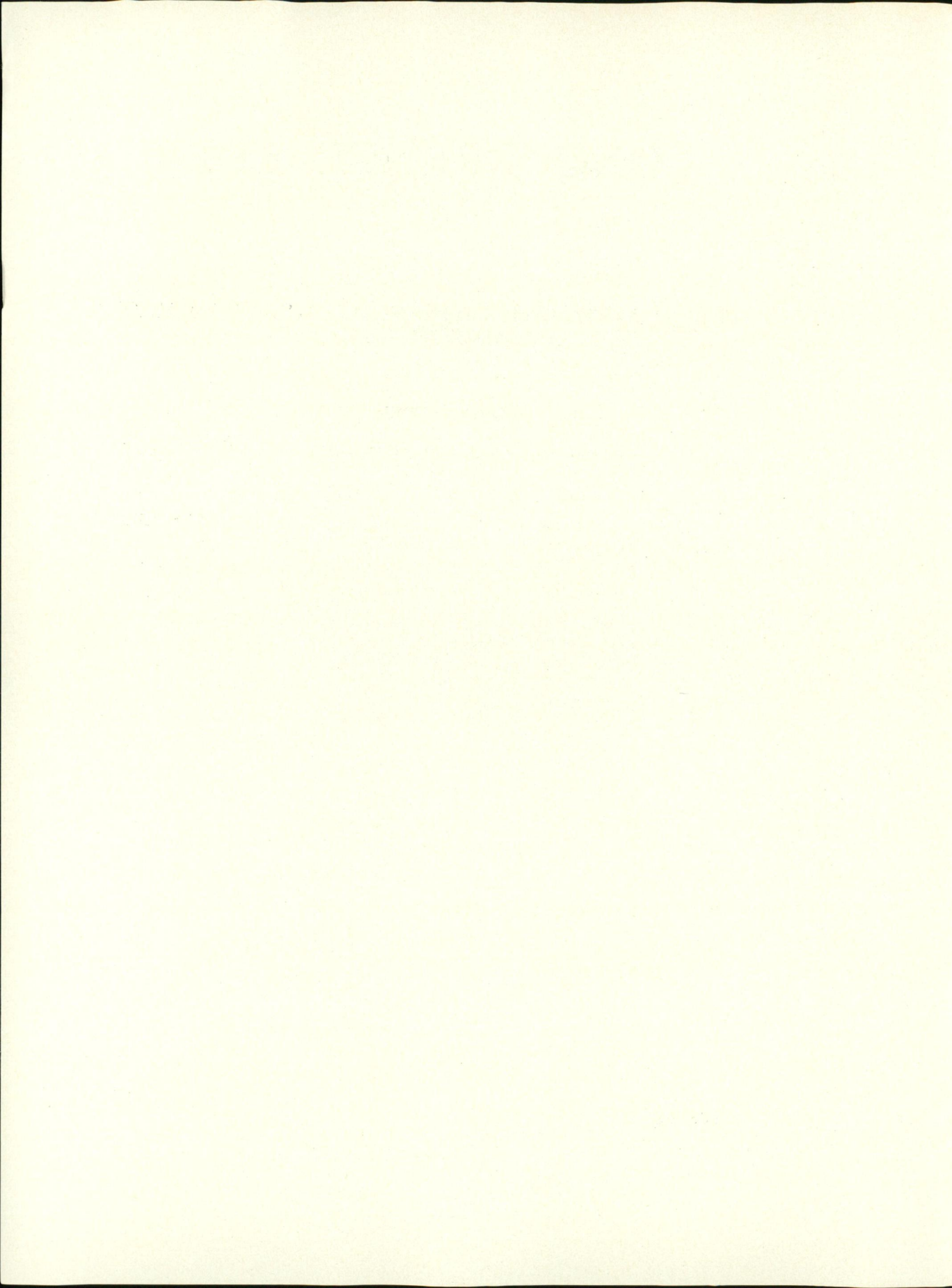
EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Treasury Corporation Bill, 1983.

The object of this Bill is to amend the Public Authorities (Financial Accommodation) Act, 1981 ("the Principal Act")—

- (a) as a consequence of the enactment of the Treasury Corporation Act, 1983 (Schedule 1 (1), (2)); and
 - (b) to bring certain county councils within the operation of the Principal Act (Schedule 1 (3), (4)).

A BILL FOR

An Act to amend the Public Authorities (Financial Accommodation) Act, 1981, as a consequence of the enactment of the Treasury Corporation Act, 1983, and for other purposes.

Public Authorities (Financial Accommodation) Amendment.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Public Authorities (Financial Accommodation) Amendment Act, 1983".

Commencement.

2. (1) Except as provided by subsection (2), this Act shall commence 10 on the date of assent to this Act.

(2) Section 3 and Schedule 1 shall commence on the day appointed and notified under section 2 (2) of the Treasury Corporation Act, 1983.

Amendment of Act No. 82, 1981.

3. The Public Authorities (Financial Accommodation) Act, 1983, is 15 amended in the manner set forth in Schedule 1.

10 writing, otherwise directs.
