
SOCCER FOOTBALL POOLS (SPORT AND RECREATION FUND) AMENDMENT BILL, 1982

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Totalizator (Off-course Betting) Amendment Bill, 1982.

The object of this Bill is to amend the Soccer Football Pools Act, 1975, as a consequence of the enactment of the Totalizator (Off-course Betting) Amendment Act, 1982, and to provide for the disposal of revenue earned as a consequence of expenditure from the Sport and Recreation Fund.

Soccer Football Pools (Sport and Recreation Fund) Amendment.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Soccer Football Pools (Sport and Recreation Fund) Amendment Act, 1982".
