STATUTORY AND OTHER OFFICES REMUNERATION (DAIRY CORPORATION) AMENDMENT BILL, 1983

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Dairy Industry (Amendment) Bill, 1983.

The object of this Bill is to amend the Statutory and Other Offices Remuneration Act, 1975, as a consequence of the enactment of the Dairy Industry (Amendment) Act, 1983, and, in particular, to make provision for the determination of the remuneration of the proposed General Manager of the New South Wales Dairy Corporation.

A BILL FOR

An Act to amend Schedule 2 to the Statutory and Other Offices Remuneration Act, 1975, as a consequence of the enactment of the Dairy Industry (Amendment) Act, 1983.

Statutory and Other Offices Remuneration (Dairy Corporation) Amendment.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Statutory and Other Offices Remuneration (Dairy Corporation) Amendment Act, 1983".

Commencement.

2. (1) Except as provided by subsection (2), this Act shall commence 10 on the date of assent to this Act.

(2) Section 3 (2) shall commence on the day appointed and notified under section 2 (2) of the Dairy Industry (Amendment) Act, 1983.

Amendment of Act No. 4, 1976.

3. (1) The Statutory and Other Offices Remuneration Act, 1975, is 15 amended by inserting in Part 1 of Schedule 2 after the words "Full-time member of the Dairy Industry Marketing Authority, other than the Chairman or Deputy Chairman." the following words:—

General Manager of the New South Wales Dairy Corporation.

(2) The Statutory and Other Offices Remuneration Act, 1975, is 20 further amended by omitting from Part 1 of Schedule 2 the following words:—

Chairman of the Dairy Industry Marketing Authority.

Statutory and Other Offices Remuneration (Dairy Corporation) Amendment.

Deputy Chairman of the Dairy Industry Marketing Authority.

Full-time member of the Dairy Industry Marketing Authority, other than the Chairman or Deputy Chairman.

Short title.

3. (1) The Statutory and Other Offices Remuneration Act, 1975, is amended by inserting in Part 1 of Schedule 2 after the words "Full-time member of the Dairy Industry Marketing Authority, other than the Chairman or Deputy Chairman." the following words:—

General Manager of the New South Wales Dairy Corporation.

(2) The Statutory and Other Offices Remuneration Act, 1975, is further amended by omitting from Part 1 of Schedule 2 the following words:—

Chairman of the Dairy Industry Marketing Authority.

Statutory and Other Offices Remuneration (Dairy Corporation) Amendment.

Deputy Chairman of the Dairy Industry Marketing Authority.

Full-time member of the Dairy Industry Marketing Authority, other than the Chairman or Deputy Chairman.
