STATUTORY AND OTHER OFFICES REMUNERATION (METROPOLITAN WATER SEWERAGE AND DRAINAGE BOARD) AMENDMENT BILL, 1983

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Metropolitan Water, Sewerage, and Drainage (Amendment) Bill, 1983.

The object of this Bill is to amend the Statutory and Other Offices Remuneration Act, 1975, consequentially upon the proposed reconstitution of The Metropolitan Water Sewerage and Drainage Board so as to provide for the salaries of the General Manager and Deputy General Manager of the Board to be determined by the Statutory and Other Offices Remuneration Tribunal.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Statutory and Other Offices Remuneration (Metropolitan Water Sewerage and Drainage Board) Amendment Act, 1983".

Commencement.

10 2. (1) Except as provided by this section, this Act shall commence on the date of assent to this Act.

(2) Section 3 (2) shall commence on the day appointed and notified under section 2 (3) of the Metropolitan Water, Sewerage, and Drainage (Amendment) Act, 1983.
