

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Metropolitan Water, Sewerage, and Drainage (Amendment) Bill, 1983.

The object of this Bill is to amend the Statutory and Other Offices Remuneration Act, 1975, consequentially upon the proposed reconstitution of The Metropolitan Water Sewerage and Drainage Board so as to provide for the salaries of the General Manager and Deputy General Manager of the Board to be determined by the Statutory and Other Offices Remuneration Tribunal.


