### **A BILL FOR**

An Act to apply certain sums out of the Consolidated Fund and the Road Transport and Traffic Fund, towards the services of the Year 1982–1983.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**5 Short title.**

1. This Act may be cited as the "Supply Act, 1982".

**\$773,235,000 may be issued out of the Consolidated Fund.**

2. Out of the Consolidated Fund there is hereby appropriated and may be issued and applied, the sum of \$773,235,000 to be expended at the rates  
10 which have been sanctioned in respect of appropriations from the Consolidated Revenue Fund for the financial year ended 30th June, 1982, to defray the expenses of the various Departments and Services of the State during the months of October and November of the financial year ending 30th June, 1983, subject to the rate of any reduction that may hereafter be made in the  
15 expenditure of the year 1982–1983.

**\$13,327,000 may be issued out of the Road Transport and Traffic Fund.**

3. Out of the Road Transport and Traffic Fund there is hereby appropriated and may be issued and applied, the sum of \$13,327,000 to be expended at the rates which have been sanctioned for the financial year ended 30th  
20 June, 1982, to defray the salaries, maintenance and working expenses and other expenses of the Department of Motor Transport during the months of October and November of the financial year ending 30th June, 1983, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1982–1983.

**25 Treasurer to pay under Governor's warrant or order.**

4. The Treasurer shall issue and pay the sums appropriated by this Act in such manner and in such proportions as the Governor, by warrants or orders in writing under his hand, and directed to the Treasurer, shall from time to time order and direct.

**Treasurer to have credit and receipts to discharge him.**

5. **BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**Short title.**

1. This Act may be cited as the "Supply Act, 1982".

**\$773,235,000 may be issued out of the Consolidated Fund.**

2. Out of the Consolidated Fund there is hereby appropriated and may be issued and applied, the sum of \$773,235,000 to be expended at the rates which have been sanctioned in respect of appropriations from the Consolidated Revenue Fund for the financial year ended 30th June, 1982, to defray the expenses of the various Departments and Services of the State during the months of October and November of the financial year ending 30th June, 1983, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1982–1983.

**\$13,327,000 may be issued out of the Road Transport and Traffic Fund.**

3. Out of the Road Transport and Traffic Fund there is hereby appropriated and may be issued and applied, the sum of \$13,327,000 to be expended at the rates which have been sanctioned for the financial year ended 30th June, 1982, to defray the salaries, maintenance and working expenses and other expenses of the Department of Motor Transport during the months of October and November of the financial year ending 30th June, 1983, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1982–1983.

**Treasurer to pay under Governor's warrant or order.**

4. The Treasurer shall issue and pay the sums appropriated by this Act in such manner and in such proportions as the Governor, by warrants or orders in writing under his hand, and directed to the Treasurer, shall from time to time order and direct.

**Treasurer to have credit and receipts to discharge him.**
