
#### **EXPLANATORY NOTE**

## (This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to make provision, pending the enactment of the Appropriation Act, 1983, for the Government to make payments during the months of October and November, 1983, in respect of regularly recurring services and ordinary contingencies, from the funds and in the amounts as follows:—

An Act to apply certain sums out of the Consolidated Fund and the Road Transport and Traffic Fund, towards the services of the Year 1983– 1984.

### Supply.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

#### 5 Short title.

1. This Act may be cited as the "Supply Act, 1983".

## \$921,500,000 may be issued out of the Consolidated Fund for recurrent services.

2. Out of the Consolidated Fund there is hereby appropriated and may 10 be issued and applied, the sum of \$921,500,000 to be expended at the rates which have been sanctioned in respect of appropriations from the Consolidated Fund for the financial year ended 30th June, 1983, to defray the expenses of the various Departments and Services of the State during the months of October and November of the financial year ending 30th June,

15 1984, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1983-84.

## \$82,545,000 may be issued out of the Consolidated Fund for capital works and services.

3. Out of the Consolidated Fund there is hereby appropriated and may 20 be issued and applied, the sum of \$82,545,000 to be expended at the rates which have been sanctioned in respect of appropriations from the Consolidated Fund for the financial year ended 30th June, 1983, to meet the capital works and services expenditure of the various Departments and Services of the State during the months of October and November of the financial year

25 ending 30th June, 1984, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1983–1984.

#### \$19,585,000 may be issued out of the Road Transport and Traffic Fund.

4. Out of the Road Transport and Traffic Fund there is hereby appropriated and may be issued and applied, the sum of \$19,585,000 to be ex-30 pended at the rates which have been sanctioned for the financial year ended

30th June, 1983, to defray the salaries, maintenance and working expenses and other expenses of the Department of Motor Transport during the months of October and November of the financial year ending 30th June, 1984, subject to the rate of any reduction that may hereafter be made in the


#### Treasurer to have credit and receipts to discharge him.







**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

#### Short title.

1. This Act may be cited as the "Supply Act, 1983".

#### \$19,585,000 may be issued out of the Road Transport and Traffic Fund.

4. Out of the Road Transport and Traffic Fund there is hereby appropriated and may be issued and applied, the sum of \$19,585,000 to be expended at the rates which have been sanctioned for the financial year
