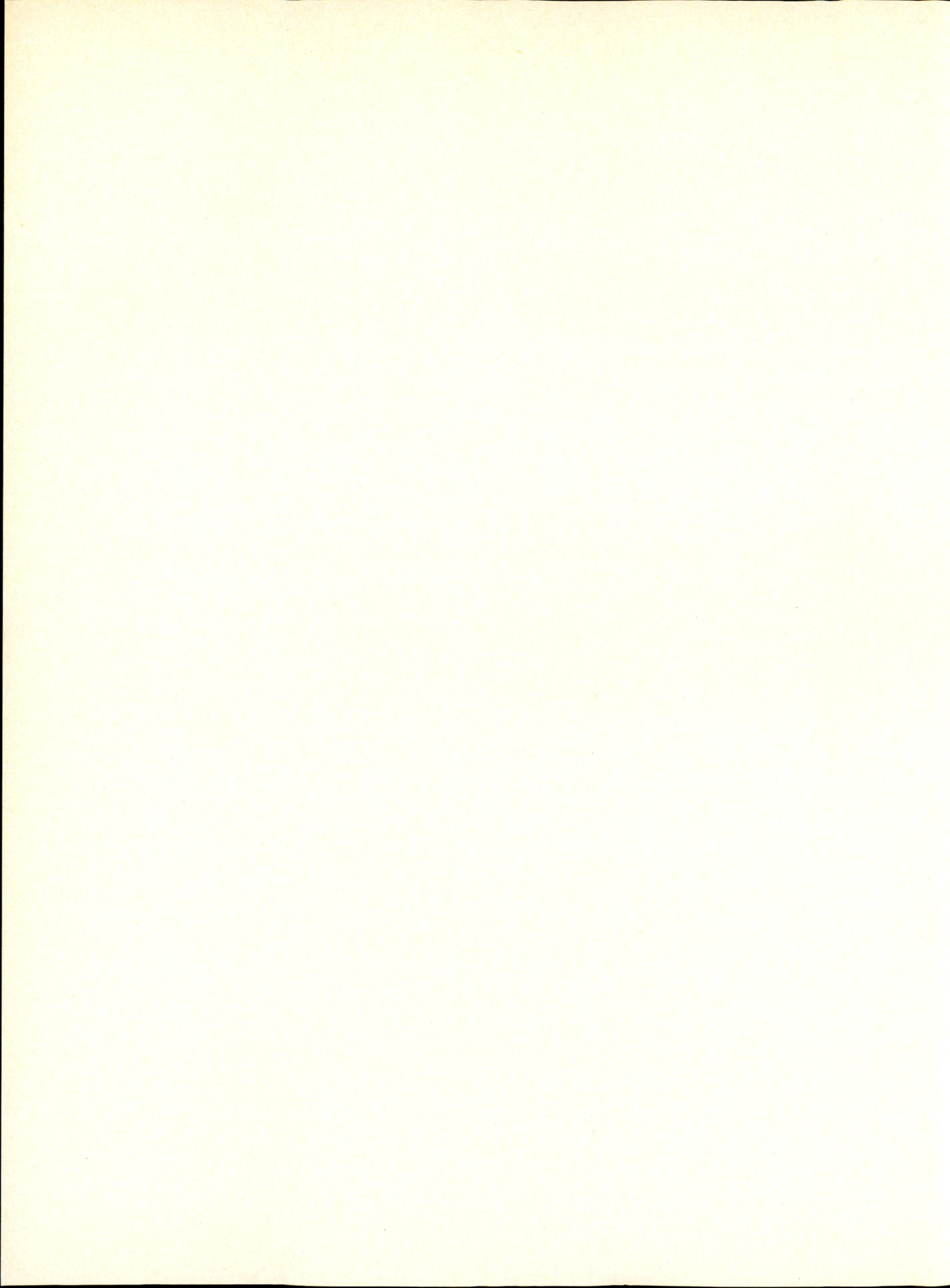
TISSUE GRAFTING AND PROCESSING (REPEAL) BILL, 1983

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Human Tissue Bill, 1983.

The object of this Bill is to repeal the Tissue Grafting and Processing Act, 1955, and to make a transitional provision to the effect that an authority under that Act for the removal of certain tissue from the body of a deceased person shall be deemed to be an authority under the proposed Human Tissue Act, 1983, for the removal of that tissue.

An Act to repeal the Tissue Grafting and Processing Act, 1955, and the Tissue Grafting and Processing (Amendment) Act, 1966, and for certain other purposes.

Tissue Grafting and Processing (Repeal).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Tissue Grafting and Processing (Repeal) Act, 1983".

Commencement.

2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.

10 (2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Human Tissue Act, 1983.

Repeals.

3. The Tissue Grafting and Processing Act, 1955, and the Tissue Graft-
15 ing and Processing (Amendment) Act, 1966, are repealed.

Transitional.

4. An authority which was in force under section 2 of the Tissue
Grafting and Processing Act, 1955, immediately before the commencement
of this section shall be deemed to be an authority in force under Part IV of
20 the Human Tissue Act, 1983.

An Act to repeal the Tissue Grafting and Processing Act, 1955, and the Tissue Grafting and Processing (Amendment) Act, 1966, and for certain other purposes. [Assented to, 31st December, 1983.]

Tissue Grafting and Processing (Repeal).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Tissue Grafting and Processing (Repeal) Act, 1983".

Commencement.

2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.

(2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Human Tissue Act, 1983.

Repeals.

3. The Tissue Grafting and Processing Act, 1955, and the Tissue Grafting and Processing (Amendment) Act, 1966, are repealed.

Transitional.

4. An authority which was in force under section 2 of the Tissue Grafting and Processing Act, 1955, immediately before the commencement of this section shall be deemed to be an authority in force under Part IV of the Human Tissue Act, 1983.
