TOTALIZATOR (AMENDMENT) BILL, 1982

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Totalizator (Off-course Betting) Amendment Bill, 1982.

The object of this Bill is to authorise the payment of totalizator dividends in multiples of 5 cents instead of multiples of 10 cents and to provide for a transfer of funds from the Racecourse Development Fund to the Consolidated Fund.

A BILL FOR

An Act to amend the Totalizator Act, 1916, with respect to the calculation of dividends and for other purposes.

Totalizator (Amendment).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Totalizator (Amendment) Act, 1982".

Commencement.

2. (1) Except as provided by subsection (2), this Act shall commence on the date of assent to this Act.

- 10 (2) Section 4 shall commence on such day as may be appointed by the Governor in respect thereof and as may be notified by proclamation published in the Gazette.

Principal Act.

3. The Totalizator Act, 1916, is referred to in this Act as the Principal
15 Act.

Amendment of Act No. 75, 1916.

4. The Principal Act is amended—

- (a) by omitting from section 9C (3) (b) the words "not more" wherever occurring and by inserting instead the word "less";

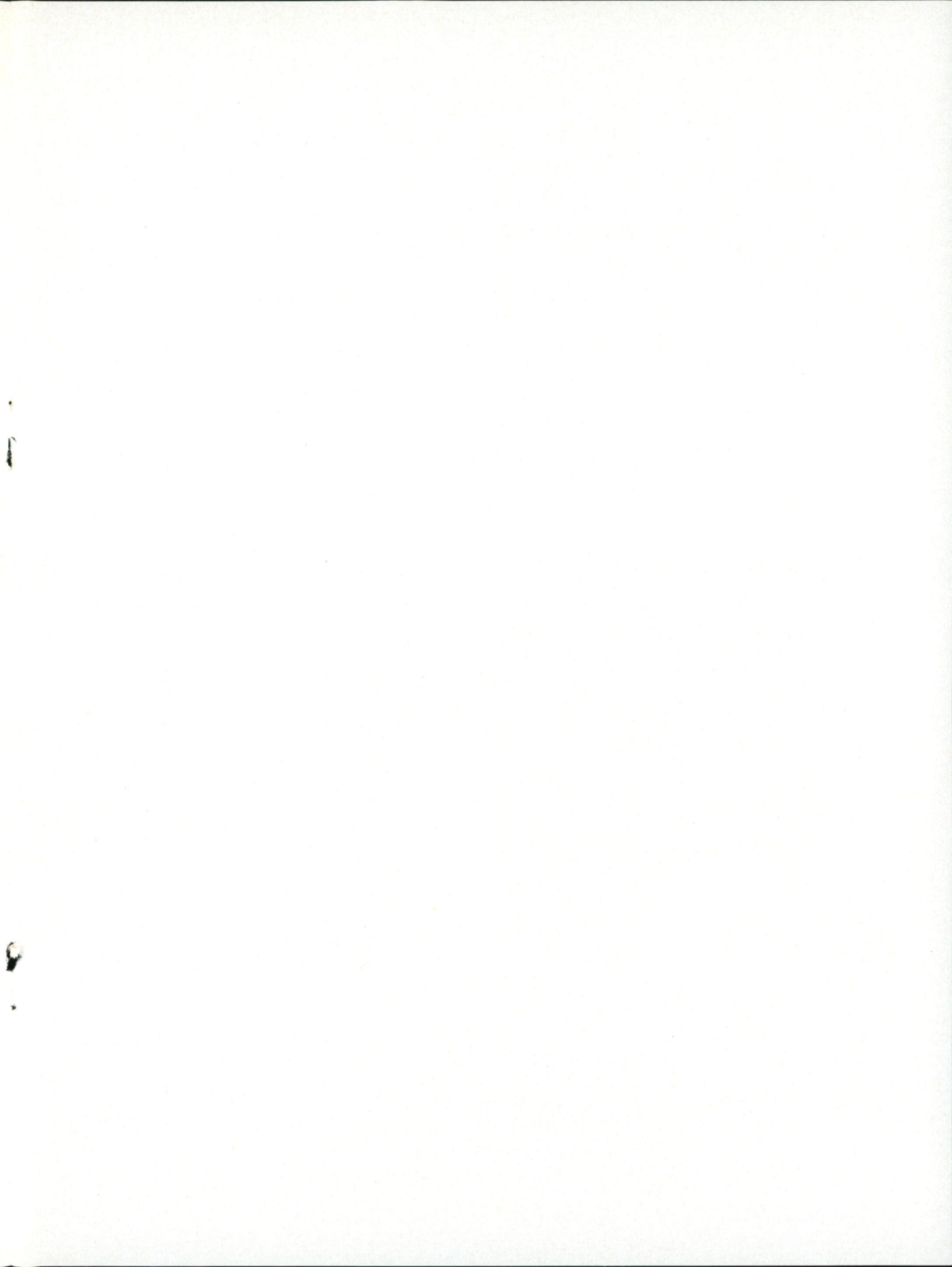

Totalizator (Amendment).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Totalizator (Amendment) Act, 1982".

Commencement.

2. (1) Except as provided by subsection (2), this Act shall commence on the date of assent to this Act.
