A BILL FOR

An Act to amend the Tourist Industry Development Act, 1976, with respect
to the Tourist Industry Development Fund established under that Act.

Tourist Industry Development (Amendment).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Tourist Industry Development (Amendment) Act, 1982".

Amendment of Act No. 58, 1976.

2. The Tourist Industry Development Act, 1976, is amended by inserting **10** in section 7 (2) after the word "Fund" where firstly occurring the words "(including money paid into the Fund pursuant to section 13B (3) (b) of the Totalizator (Off-course Betting) Act, 1964)".

An Act to amend the Tourist Industry Development Act, 1976, with respect to the Tourist Industry Development Fund established under that Act. [Assented to, 24th December, 1982.]

Tourist Industry Development (Amendment).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Tourist Industry Development (Amendment) Act, 1982".

Amendment of Act No. 58, 1976.

2. The Tourist Industry Development Act, 1976, is amended by inserting in section 7 (2) after the word "Fund" where firstly occurring the words "(including money paid into the Fund pursuant to section 13B (3) (b) of the Totalizator (Off-course Betting) Act, 1964)".
