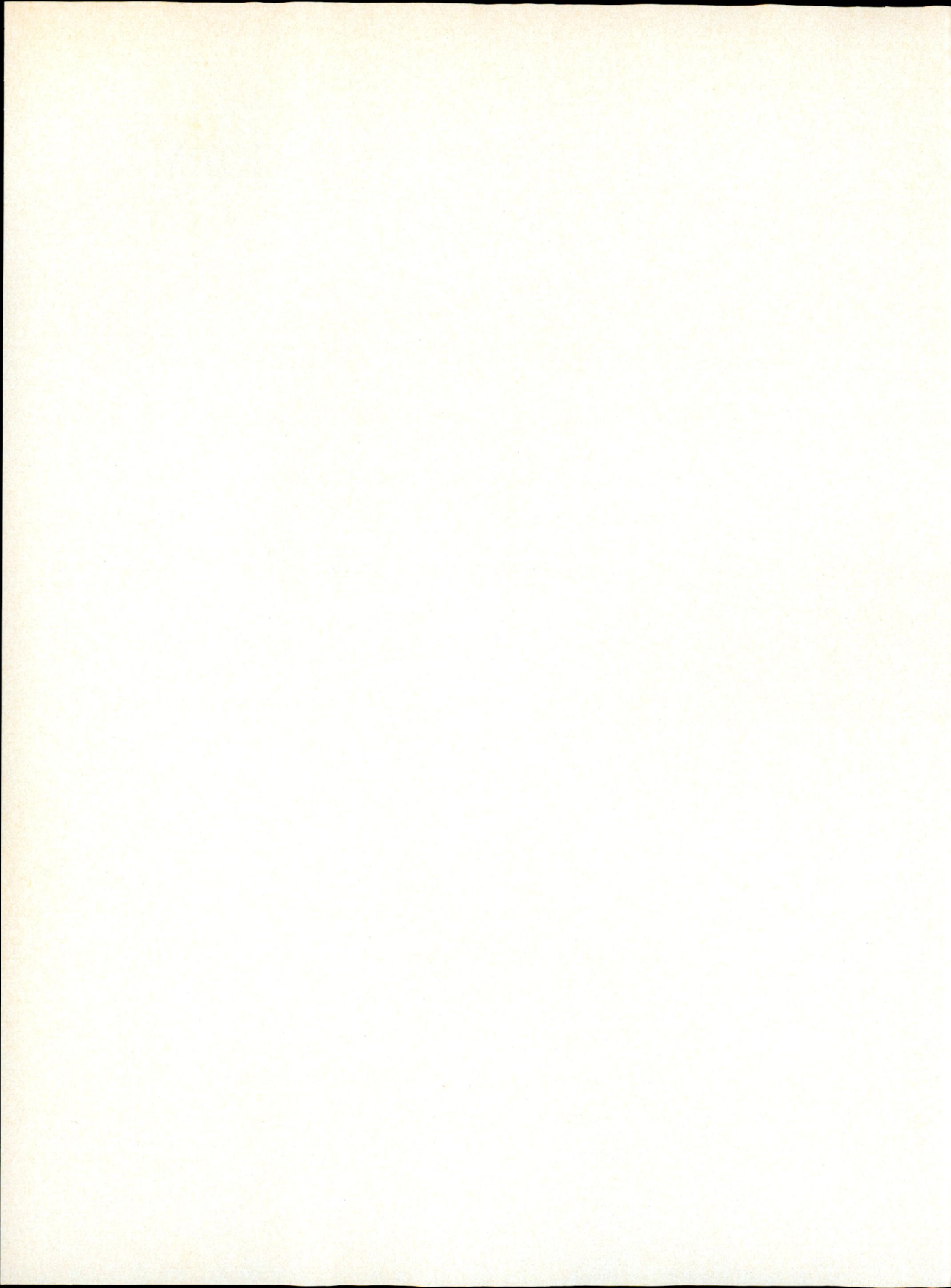
### EXPLANATORY NOTE

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

This Bill is cognate with the Motor Traffic (Further Amendment) Bill, 1983.

The object of this Bill is to amend section 202 of the Transport Act, 1930, so as to ensure that money paid to the Commissioner for Motor Transport under the Motor Traffic Act, 1909, in relation to the issue or transfer of number-plates is paid into the Road Transport and Traffic Fund.

*Transport (Motor Traffic) Amendment.*

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**5 Short title.**

**1.** This Act may be cited as the "Transport (Motor Traffic) Amendment Act, 1983".

**Commencement.**

**2. (1)** Sections 1 and 2 shall commence on the date of assent to this Act.

**10 (2)** Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Motor Traffic (Further Amendment) Act, 1983.

**Amendment of Act No. 18, 1930.**

**3.** The Transport Act, 1930, is amended by inserting in section 202 (1) **15 (b)** after the word "charged" the words ", and all moneys paid to the Commissioner for Motor Transport in relation to the issue or transfer of number-plates,".

**Short title.**
