TRANSPORT (RECREATION VEHICLES) AMENDMENT BILL, 1983

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Recreation Vehicles Bill, 1983.

The object of this Bill is to amend section 202 of the Transport Act, 1930, so
as—

- (a) to ensure that all fees paid to the Commissioner for Motor Transport under the proposed Recreation Vehicles Act, 1983, are paid into the Road Transport and Traffic Fund; and
 - (b) to enable the Commissioner for Motor Transport to pay out of the Road Transport and Traffic Fund such amounts as may be necessary to meet the administrative and other expenses of the Commissioner in respect of the proposed Recreation Vehicles Act, 1983.

An Act to amend section 202 of the Transport Act, 1930, in relation to the Road Transport and Traffic Fund, consequent upon the enactment of the Recreation Vehicles Act, 1983.

Transport (Recreation Vehicles) Amendment.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Transport (Recreation Vehicles) Amendment Act, 1983".

Commencement.

2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.

10 (2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Recreation Vehicles Act, 1983.

3. The Transport Act, 1930, is amended in the manner set forth in 15 Schedule 1.





Short title.
