EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The State Transport (Co-ordination) Amendment Bill, 1981, is cognate with this Bill.

The object of this Bill is to amend section 202 of the Transport Act, 1930, so as—

- (a) to provide for the payment into the Road Transport and Traffic Fund of fees charged, other money paid, and penalties recovered, under the State Transport (Co-ordination) Act, 1931; and
 - (b) to provide for the payment out of that fund of the expenses incurred by the Commissioner for Motor Transport in relation to the administration of the State Transport (Co-ordination) Act, 1931.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Transport (Road Transport and Traffic Fund) Amendment Act, 1981".
