## **TRANSPORT AUTHORITIES (AMENDMENT) BILL, 1983**


#### EXPLANATORY NOTE

#### (This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to amend the Transport Authorities Act, 1980, so as-

- (a) to increase, by one, the membership of the Urban Transit Authority, the additional member being appointed by the Minister, on the nomination of the Executive Committee of the Transport Workers' Union of Australia (New South Wales Branch), to be a representative of employees in the private omnibus and taxi-cab industry (Schedule 1 (1));
- (b) to increase, by one, the quorum for meetings of the Urban Transit Authority (Schedule 1 (2)); and
- (c) to provide for the manner of making a nomination for the appointment of the additional member and for the making of such an appointment in the event of a failure to make such a nomination (Schedule 1 (3)).

# A BILL FOR

An Act to amend the Transport Authorities Act, 1980, so as to increase the membership of the Urban Transit Authority.

#### Transport Authorities (Amendment).

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

#### 5 Short title.

1. This Act may be cited as the "Transport Authorities (Amendment) Act, 1983".

#### **Commencement.**

2. (1) Except as provided by subsection (2), this Act shall commence 10 on the date of assent to this Act.

(2) Section 3 and Schedule 1 shall commence on such day as may be appointed by the Governor in respect thereof and as may be notified by proclamation published in the Gazette.

#### Amendment of Act No. 103, 1980.

15 3. The Transport Authorities Act, 1980, is amended in the manner set forth in Schedule 1.

#### Transitional provisions.

4. (1) For the purpose only of enabling the Urban Transit Authority to be constituted in accordance with the Transport Authorities Act, 1980, as 20 amended by this Act, on or after (but not before) the day appointed and notified under section 2 (2), an appointment or appointments may be made under that Act, as amended by this Act, and any other act, matter or thing may be done, before that day as if the whole of this Act commenced on the date of assent to this Act.

#### Transport Authorities (Amendment).

(2) Nothing in this Act affects the tenure of office of any member of the Urban Transit Authority holding office immediately before the day appointed and notified under section 2 (2).
