EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Industrial Arbitration (Amendment) Bill 1986.

The object of this Bill is to amend the Annual Holidays Act 1944 in consequence of the enactment of the proposed Industrial Arbitration (Amendment) Act 1986.

Clause 1 specifies the short title of the proposed Act.

Clause 2 amends section 13 (Recovery of holiday pay) of the Principal Act so as to provide that nothing in that section prevents an order from being made under section 25AA of the Industrial Arbitration Act 1940 by a conciliation commissioner, committee or tribunal in compulsory conference proceedings under section 25 of that Act.






