
APPRENTICESHIP (AMENDMENT) BILL, 1985

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to amend the Apprenticeship Act, 1981, so as to provide for the appointment of 3 additional members of the New South Wales Apprenticeship Council, one of whom shall be a woman appointed as a representative of women.

An Act to amend the Apprenticeship Act, 1981, with respect to the membership and procedure of the New South Wales Apprenticeship Council.

Apprenticeship (Amendment) 1985

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—





BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—
