BOY SCOUTS ASSOCIATION (AMENDMENT) BILL 1986

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to amend the Boy Scouts Association—New South Wales Branch Incorporation Act 1928—

- (a) to change the name of the corporation constituted under that Act, which is the controlling body of the Scout Movement in the State, to "The Scout Association of Australia, New South Wales Branch";
- (b) to streamline the procedure under that Act for dealing with property of the corporation;
- (c) to update terminology in that Act relating to the organisation of the Scout Movement in the State; and
- (d) to effect other minor amendments.

Clause 1 specifies the short title of the proposed Act.

Clause 2 is a formal provision that gives effect to the Schedule of amendments.

Schedule 1 (1) changes the short title of the Principal Act to reflect the change of name of the corporation which it constitutes.

Schedule 1 (2) (a) amends the definition of "Association" to recognise its change of name. The Association is the controlling body of the Scout Movement in Australia and is now known as The Scout Association of Australia.

Schedule 1 (2) (b) alters the definition of "Constitution" (which is the document by which functions are delegated by the Association to its N.S.W. branch) to make it clear that it means that document as amended and in force from time to time.

Schedule 1 (3) inserts a provision which effects a change of name of the New South Wales Branch of the Association. The Branch is constituted as a corporation by the Principal Act and is now to be known as The Scout Association of Australia, New South Wales Branch.

Schedule 1 (4) changes a reference from "Boy Scout" to "Scout".

Schedule 1 (5) expands the list of Scout-related terms which an unauthorised person is prohibited from using. The penalty for a contravention is increased to \$200.

Schedule 1 (6) (a) increases to \$200 the penalty for unauthorised use, wearing or sale of Scout badges, uniforms and related items.

Schedule 1 (6) (b) changes a reference from "boy scout" to "scout".

Schedule 1 (7) updates terminology in the provision dealing with vesting of property in the Corporation. References to "troop" and "pack" are updated to "group" and "section".

Schedule 1 (8) streamlines the provision of the Principal Act dealing with the manner in which the Corporation deals with and disposes of property. The provision currently requires that a proposed mortgage or sale of real property be approved by a simple majority at an ordinary meeting of the Executive Committee and approved by a twothirds majority at a later ordinary meeting. Approval by a two-thirds majority at one meeting only is all that will now be required.

Schedule 1 (9) updates provisions requiring lodgment of certain documents by the Corporation with the Corporate Affairs Commission. A copy of a document so lodged, certified by the Commission, is evidence of the contents of the document.

Schedule 1 (10) changes a reference from "general secretary" to "chief executive", to be consistent with current terminology.

Schedule 1 (11) adds to the methods provided by the Principal Act for the serving of documents on or the giving of notice to the Corporation by including delivery to the Corporation's office and service by post as acceptable methods.

Schedule 1 (12) updates the provision dealing with proceedings for offences.

Schedule 1 (13) inserts a provision which gives effect to the Schedule of savings and transitional provisions and inserts that Schedule. The proposed Schedule makes minor savings provisions concerning gifts and devises to Scouting bodies and the lodgment of documents with the Corporate Affairs Commission.

A BILL FOR

An Act to amend the Boy Scouts Association—New South Wales Branch Incorporation Act 1928 to change the name of the corporation constituted by that Act; and for other purposes. **BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

1. This Act may be cited as the "Boy Scouts Association (Amendment) Act 1986".
