EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Stamp Duties (Amendment) Bill 1985.

The object of this Bill is to provide for the appointment of a Deputy Chief Commissioner for Business Franchise Licences (Petroleum Products) (clause 2 and Schedule 1).

A BILL FOR

An Act to amend the Business Franchise Licences (Petroleum Products) Act 1982 so as to provide for the appointment of a Deputy Chief Commissioner for Business Franchise Licences (Petroleum Products).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Business Franchise Licences (Petroleum Products) (Administration) Amendment Act 1985".

Amendment of Act No. 92, 1982

2. The Business Franchise Licences (Petroleum Products) Act 1982 is

After section 11 (2), insert:

(2A) There shall be a Deputy Chief Commissioner for Business Franchise Licences (Petroleum Products), who shall assist the Chief Commissioner in the administration of this Act.

25 (2B) The person for the time being holding office or acting as Deputy Secretary of the Department of Finance shall also hold office as Deputy Chief Commissioner.

(b) Section 11 (6)–(8)—

30 Omit "the Commissioner" wherever occurring, insert instead "the Deputy Chief Commissioner".

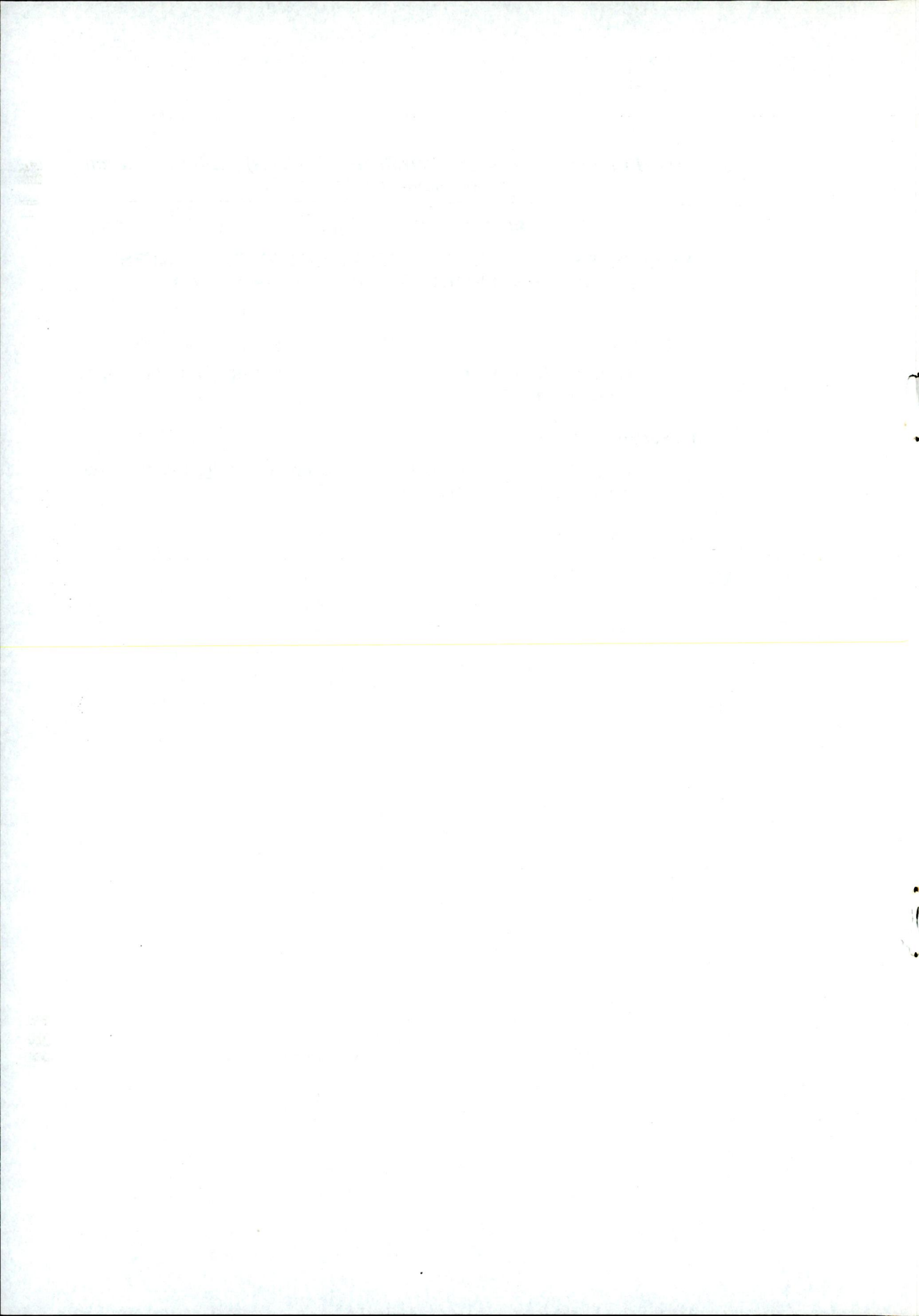

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

Short title

1. This Act may be cited as the "Business Franchise Licences (Petroleum Products) (Administration) Amendment Act 1985".

2. The Business Franchise Licences (Petroleum Products) Act 1982 is amended in the manner set forth in Schedule 1.

(2B) The person for the time being holding office or acting as Deputy Secretary of the Department of Finance shall also hold office as Deputy Chief Commissioner.

Omit "the Commissioner" wherever occurring, insert instead "the Deputy Chief Commissioner".
