## EXPLANATORY NOTE

#### (This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Public Health (Tobacco) Amendment Bill 1986.

The object of this Bill is to enable the Chief Commissioner for Business Franchise Licences (Tobacco) to refuse or cancel a licence issued under the Business Franchise Licences (Tobacco) Act 1975 in respect of a person who is convicted of the offence of selling tobacco, including cigars and cigarettes, to a person under the age of 16 years.

Clause 1 specifies the short title of the proposed Act.


Clause 2 provides that the proposed Act will, with minor exceptions, commence on the commencement of section 4 of and Schedule 2 to the proposed Public Health (Tobacco) Amendment Act 1986.

Clause 3 is a formal provision which gives effect to the Schedule of amendments.

Schedule 1 (1) gives effect to the object of the Bill in relation to the refusal of a licence.

Schedule 1 (2) gives effect to the object of the Bill in relation to the cancellation of a licence.

# A BILL FOR

An Act to amend the Business Franchise Licences (Tobacco) Act 1975 with respect to the refusal and cancellation of certain licences.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

## 5 Short title

1. This Act may be cited as the "Business Franchise Licences (Tobacco) Further Amendment Act 1986".

#### Commencement

2. (1) Sections 1 and 2 shall commence on the date of assent to this 10 Act.

(2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (3) of the Public Health (Tobacco) Amendment Act 1986.




