### **EXPLANATORY NOTE**

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

This Bill is cognate with the Tourism Commission Bill, 1984.

The object of this Bill is to amend the Schedule to the Capital Debt Charges Act, 1957, in consequence of the enactment of the proposed Tourism Commission Act, 1984, so as to provide for the payment to the Treasurer by the Tourism Commission of New South Wales of amounts in reduction of its loan liability, within the meaning of the Capital Debt Charges Act, 1957.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**5 Short title.**

**1.** This Act may be cited as the "Capital Debt Charges (Tourism Commission) Amendment Act, 1984".

**Commencement.**
