EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

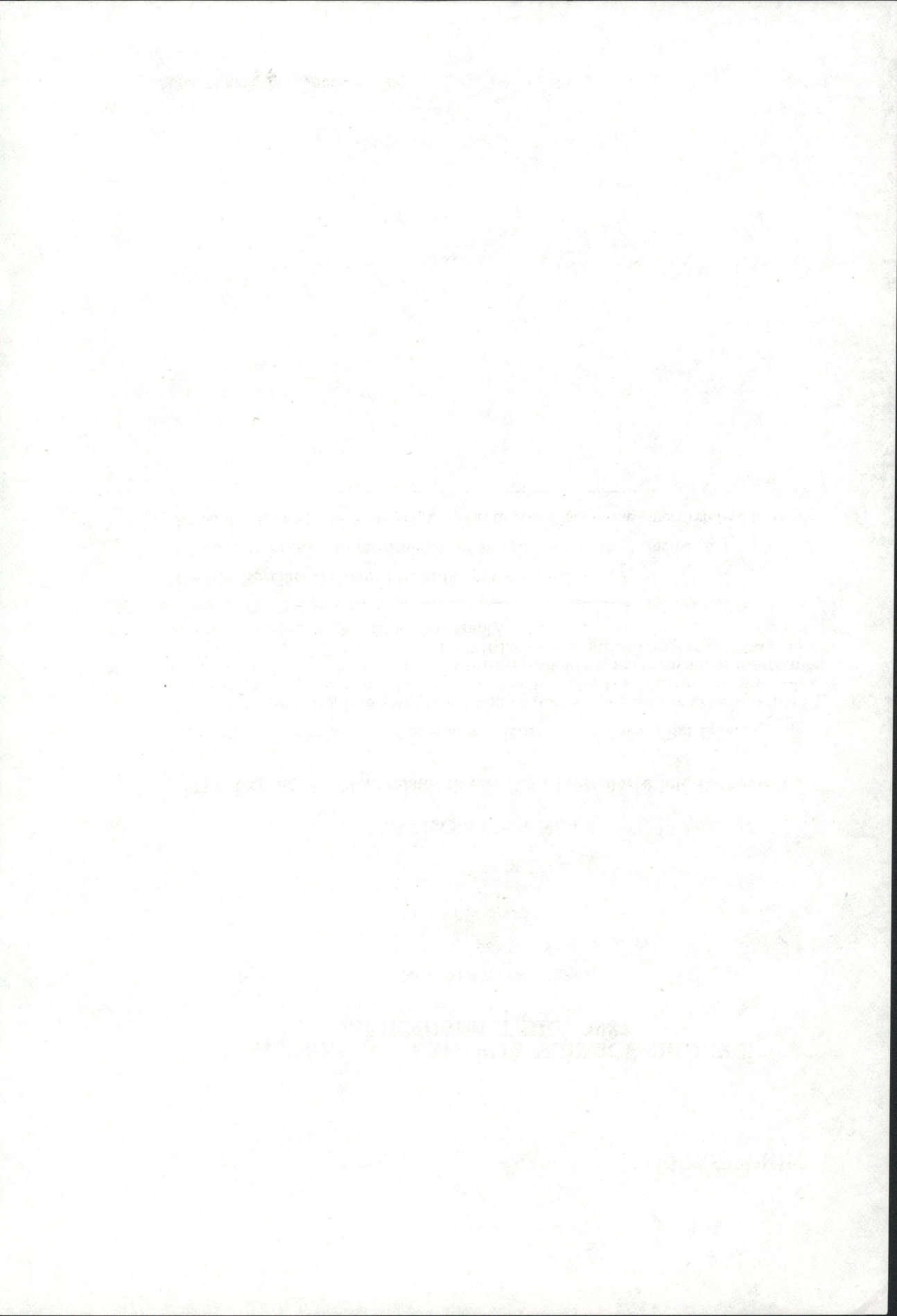
This Bill is cognate with the Community Welfare (Amendment) Bill 1987.

The object of this Bill is to amend the Children (Community Service Orders) Act 1987 so as to enable a warrant for the arrest of a person who has failed to comply with a children's community service order to be issued without the requirement, as is presently provided by that Act, that the person must have first failed to appear in answer to a summons in respect of that failure to comply.

Clause 1 specifies the short title of the proposed Act.

Clause 2 gives effect to the Schedule of amendments to the Principal Act.

Schedule 1 amends the Principal Act so as to give effect to the object referred to above.

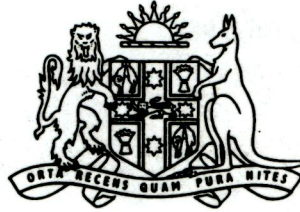

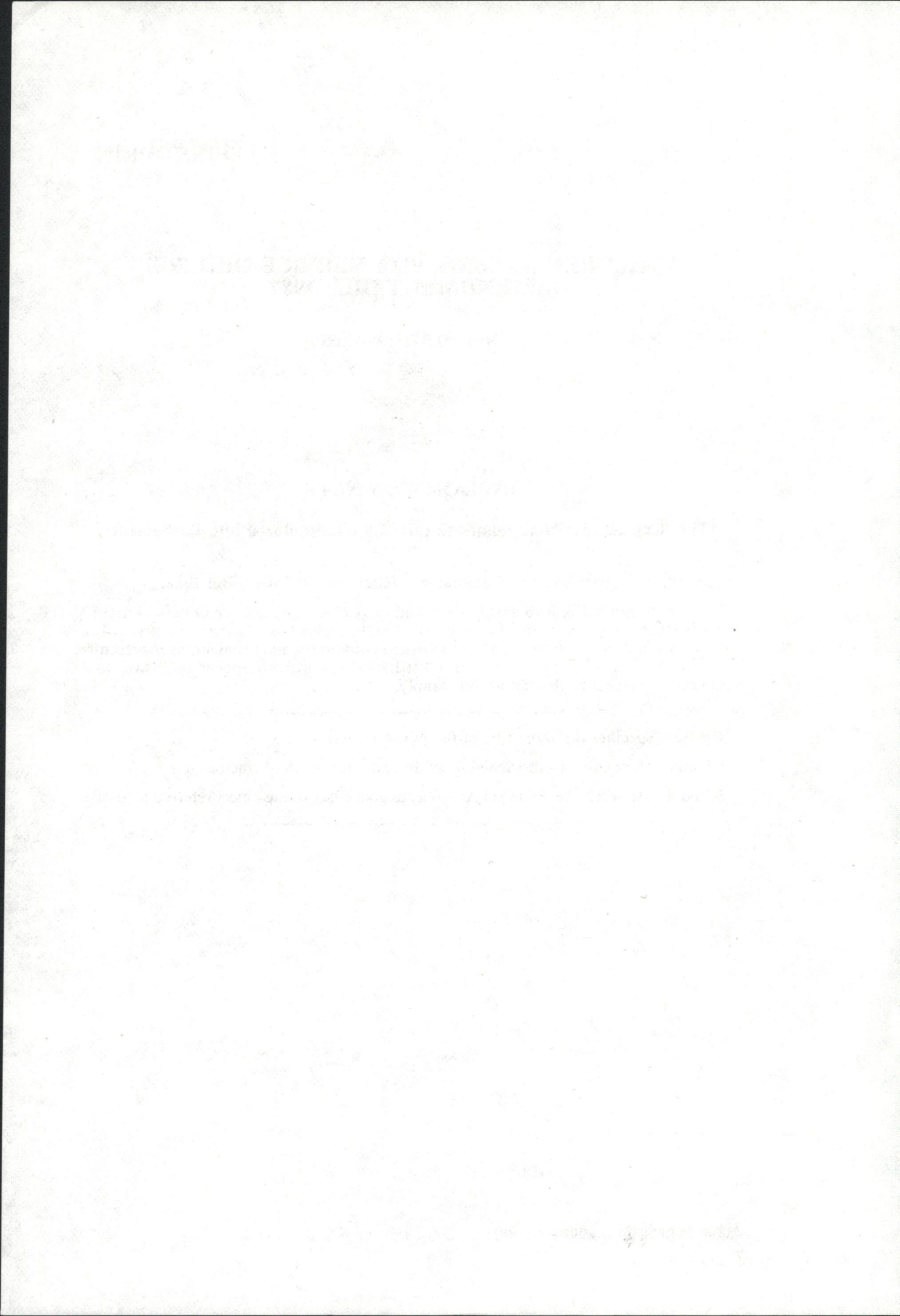

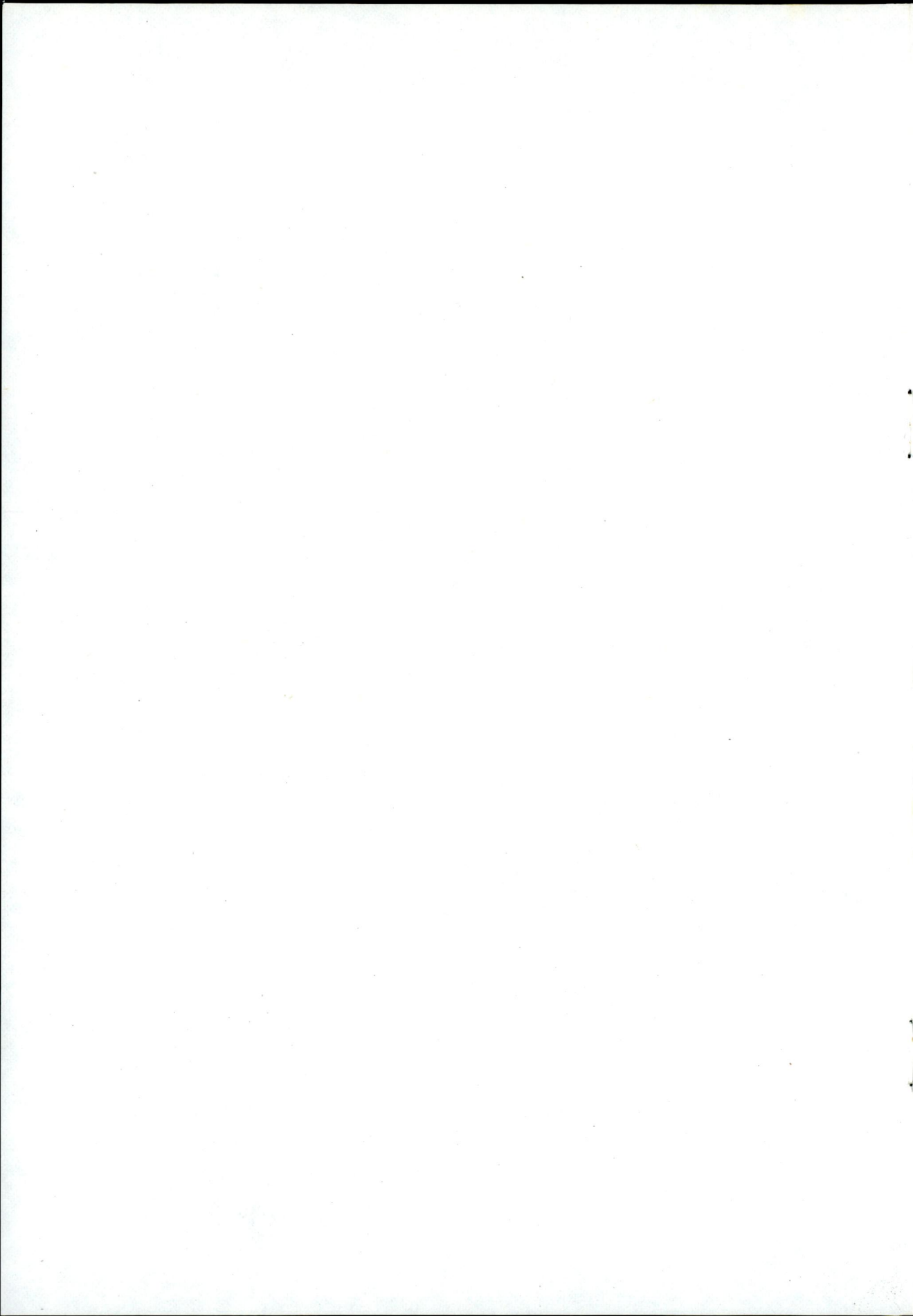
