

**CIGARETTES (LABELLING) AMENDMENT AND REPEAL
BILL 1986**

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Public Health (Tobacco) Amendment Bill 1986.

The objects of this Bill are, as a consequence of the enactment of the proposed Public Health (Tobacco) Amendment Act 1986—

- (a) to amend the Cigarettes (Labelling) Act 1972 to limit the application of that Act to cigarettes manufactured in Australia before 1 July 1987 and cigarettes manufactured outside Australia before 1 September 1987; and
- (b) to enable the repeal of the Cigarettes (Labelling) Act 1972 on a day to be appointed by the Governor by proclamation.

Clause 1 specifies the short title of the proposed Act.

Clause 2 amends the Principal Act to give effect to the object set out in paragraph (a) above. The clause also enables cigarettes to which the Principal Act applies to be sold in packages that comply with the new requirements for health warnings inserted into the Public Health Act 1902 by the proposed Public Health (Tobacco) Amendment Act 1986.

Clause 3 gives effect to the object set out in paragraph (b) above.

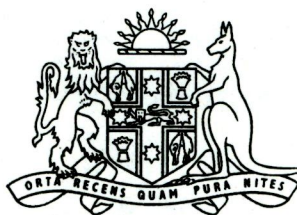

A BILL FOR

An Act to amend the Cigarettes (Labelling) Act 1972 to limit its application and to enable its repeal.

Cigarettes (Labelling) Amendment and Repeal 1986

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Cigarettes (Labelling) Amendment and Repeal Act 1986".

Amendment of Act No. 51, 1972

2. The Cigarettes (Labelling) Act 1972 is amended by inserting after
10 section 3 the following section:

Application of Act

3A. (1) This Act applies to and in respect of the sale of—

(a) cigarettes manufactured in Australia before 1 July 1987; and

15 (b) cigarettes manufactured outside Australia before 1 September
1987.

(2) Notwithstanding subsection (1), it is not an offence against this Act
for a person to sell cigarettes manufactured in Australia before 1 July
1987 or cigarettes manufactured outside Australia before 1 September
20 1987 if the package in which they are enclosed is marked with a health
warning in accordance with the Third Schedule to the Public Health Act
1902.

Repeal of Act No. 51, 1972

3. On a day (not earlier than 1 September 1987) to be appointed by the
Governor and notified by proclamation published in the Gazette, the
25 Cigarettes (Labelling) Act 1972 is repealed.



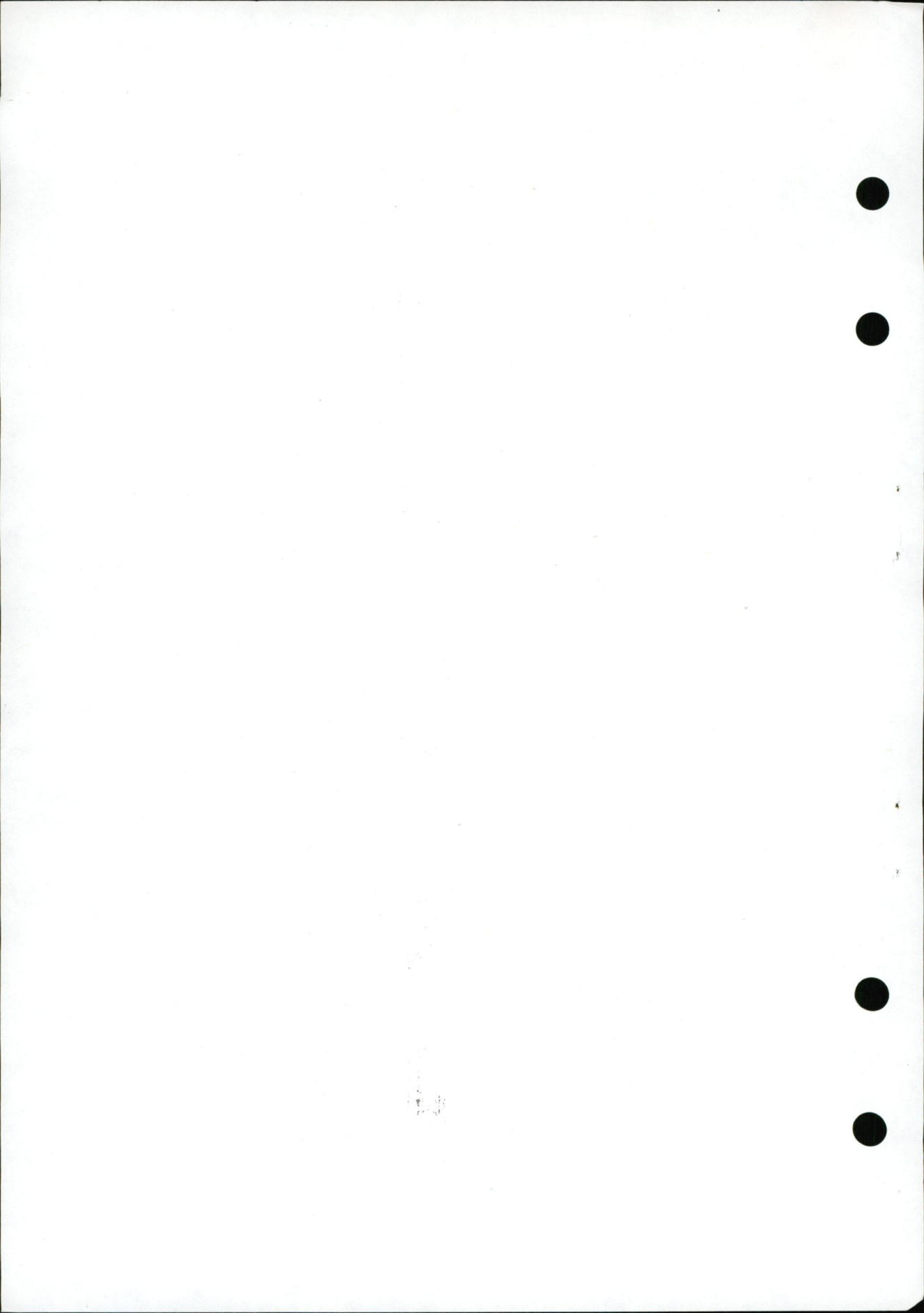

An Act to amend the Cigarettes (Labelling) Act 1972 to limit its application and to enable its repeal. [Assented to 17 December 1986]

Cigarettes (Labelling) Amendment and Repeal 1986

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

Short title

1. This Act may be cited as the "Cigarettes (Labelling) Amendment and Repeal Act 1986".

Amendment of Act No. 51, 1972

2. The Cigarettes (Labelling) Act 1972 is amended by inserting after section 3 the following section:

Application of Act

3A. (1) This Act applies to and in respect of the sale of—

- (a) cigarettes manufactured in Australia before 1 July 1987; and
- (b) cigarettes manufactured outside Australia before 1 September 1987.

Repeal of Act No. 51, 1972

3. On a day (not earlier than 1 September 1987) to be appointed by the Governor and notified by proclamation published in the Gazette, the Cigarettes (Labelling) Act 1972 is repealed.
