COMPENSATION COURT (AMENDMENT) BILL, 1985

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Workers' Compensation (Amendment) Bill, 1985. The objects of this Bill are—

- (a) to repeal the provisions of the Compensation Court Act, 1984, relating to the appointment and functions of commissioners of the Compensation Court ("the Court") (Schedule 1 (3) and (9));
- (b) to enact provisions as a consequence of, and in connection with, the enactment of the Workers' Compensation (Amendment) Act, 1985, and, in particular, as a consequence of—
 - (i) the proposed appointment under the Workers' Compensation Act, 1926, of commissioners of the Court; and
 - (ii) the transfer of certain functions of the Court to the commissioners;
- (c) to provide that a plea of issue estoppel is not available in any court in respect of a matter decided by a commissioner of the Court (Schedule 1 (6) (f));
- (d) to provide that regulations made under the Workers' Compensation Act, 1926, in relation to proceedings under that Act prevail over any rules of the Court to the extent of any inconsistency (Schedule 1 (17) (b)); and
- (e) to make other provisions of a minor, consequential or ancillary nature.

An Act to amend the Compensation Court Act, 1984, as a consequence of, and in connection with, the enactment of the Workers' Compensation (Amendment) Act, 1985, and in certain other respects.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Compensation Court (Amendment) Act, 1985".

Commencement.

- 2. (1) Except as provided by subsections (2) and (3), this Act shall 10 commence on the date of assent to this Act.
 - (2) The several provisions of Schedule 1 shall commence on such day or days as may be appointed by the Governor in respect thereof and as may be notified by proclamation published in the Gazette.



BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Compensation Court (Amendment) Act, 1985".
